# START Model Programs 2022-23 Annual Report



## The START Model

Our mission is to provide community mobilization services for the communities that we support throughout Manitoba. We are a consent-based, culturally inclusive and client centred program that seeks to identify the challenges our clients face, support them with multi-disciplinary teams and assist them in reaching their individual goals. Ultimately, this creates healthier and safer communities for everyone.

Our model operates in four regions in Manitoba:

Selkirk and area (START Youth, Re-START Selkirk and START Families)

Dauphin and area (D.A.R.T.-Dauphin At-Risk Teens and Re-START Dauphin)

Gimli and area (F.Y.R.S.T-Family and Youth Regional Support Team and Re-START Gimli)

Steinbach and area (Headway and Re-START Steinbach)

START Model Programs operate on First Nation Treaty Territories 1 and 2, and on the homeland of the Métis Nation. We respect that First Nations treaties were made on these territories, acknowledge harms and mistakes, and dedicate ourselves to collaborate in partnership with First Nations, Inuit and Métis peoples in the spirit of reconciliation.

#### 20 Years of Collaboration

The START Program reached the 20-year milestone in 2022 and it was important to us to take the time to celebrate all of the organizations that partner with us to assist our participants, as without them, we would not be able to have the impact we do. Collaboration is the keystone of the START model and we are always looking at ways to improve agency relationships including by surveying our partner service providers annually. We are pleased with the positive feedback support team members have provided us:

- 98% report participating was a good use of their time
- 78% better understand other agencies' policies
- 81% report the participant is making healthier choices
- 81% report the family has an increased capacity to meet their own needs

We are extremely grateful for all of the agency partnerships we have and are always seeking new connections on behalf of our participants. If you are already one of our community partners, thank you for joining with our teams. If you are not yet, we look forward to working with you in the future.

## Collective Outcomes of START Model Programs in 2022-23

#### For Youth and Their Families

91%	Of participants connected to new services through their involvement with the programs
84%	Of participants were kept safe through a plan created by their support team
70%	Of participants improved their attendance and participation in school
71%	Of participants had improved academics at school
72%	Of participants showed improvement in their living situation or familial relationships
96%	Of participants had fewer or no criminal charges since participation

#### Enhancing Employability

- **33%** Of participants became employed while with Re-START
- 18% Of participants who have returned to high school, trade school or are in work placement programs

#### START Youth

96% of participants had fewer or no criminal charges since becoming a participant

67% of participants completed their probation

78% of participants had improved school attendance

79% had improved school academics

77% had an improved living situation

**92%** of participants felt they had an increased capacity to set goals

84% of participants showed a reduction of risk factors

88% of participants were connected to new services

"My work with The START Program has greatly enhanced the work I do as a Community Policing Officer. Instead of a general audience, I now get to work on a team that is working together for the benefit of the youth. I have the honor of being invited onto that team that allows me to share what the police can provide but also the opportunity to form a positive relationship with someone. The payback for all of this effort is that the youth will get the opportunity to lead a full life and know they are not alone."

### Re-START Selkirk

**92%** of participants had fewer or no criminal charges once becoming involved in Re-START

**50%** decrease in the number of police calls for service once becoming involved with Re-START

93% of participants who were experiencing homelessness or were living in inadequate housing who found a place to live

88% of participants showed a reduction of risk factors

**93%** of participants were kept safe through a plan created by their support team

85% of participants felt they had an increased capacity to set goals

**79%** of participants were connected to new services

"With the help of The START Program we have been able to get resources that we had trouble getting in the past, for example we were part of a parenting group and getting support with Anxiety. We have also had the support of our team who wants the best for our child and they have played an active part in helping him with schooling and his personal life. Through The START Program we have been able to get him a support worker who takes him out weekly which gives us a breather from each other while giving him someone that he can talk to.

## Introducing... START Families

START Families is a consent-based community mobilization program. Utilizing the START and Safe & Together Models, we assist adults who are perpetrators of domestic violence to create new outcomes for their families.

START Families is a two-phase program:

Phase 1:

- Focuses on ending abusive behaviours displayed by the perpetrator of the domestic violence and works with them to be accountable for their pattern of behaviour and choices
- Promotes a shift towards creating stability, healing, and healthy families while ensuring that the perpetrator is responsible for their abuse behaviours

#### Phase 2:

• Assists the program participant to define and achieve goals that will assist in maintaining positive life choices utilizing the START Model

- St. Clements
- Brokenhead Ojibway Nation

- Beausejour
- Oakbank
- Ste. Anne
- Steinbach

88% decrease in calls for police service relating to domestic violence for those who engage

67% of referrals engage with START Families

100% increase in family visits for participants that had restricted access

100% of participants had safety plans generated by START Families

53% of participants were also referred to new services

"I think START Families is a great program! Our agency (CFS) has tons of cases where DV is present and this program has done a great job at holding the perpetrators accountable. Since our caseloads are very heavy it would be impossible to have in depth conversations about their abusive behaviours with the perpetrators let alone begin to address them, so it is very helpful to have a program where that can happen."

67% of participants had improved school attendance

79% had improved school academics

77% had an improved living situation

**92%** of participants felt they had an increased capacity to set goals

84% of participants showed a reduction of risk factors

**88%** of participants were connected to new services

83% decrease in the number of police calls for service once becoming involved with Re-START

87% of participants who were experiencing homelessness or were living in inadequate housing who found a place to live

64% of participants showed a reduction of risk factors

83% of participants were kept safe through a plan created by their support team

**70%** of participants were connected to new services

87% of participants were connected to more appropriate services

"As a teenager, I was in the DART Program, and I liked working with the coordinator. As an adult, I needed help. My children are in the care of their dad, and he would not let me see them unless I changed. The Re-START Program helped make those changes. I have a long way to go but I now have housing, changed my drug use that kept me away from my children and work on my anger. I now spend time with my children and get them for the weekend sometimes. Their dad and I can talk to each other without my anger getting in the way."

**71%** of participants are no longer involved in the Justice system

**75%** of participants had improved school attendance

82% had improved school academics

58% had an improved living situation

**IOO%** of participants felt they had an increased capacity to set goals

**50%** of participants showed a reduction of risk factors

86% of participants were connected to new services

"I have really appreciated Janina's work and support for the family, but also the team supporting the family. Keeping everyone accountable and following up on goals and next steps is a really great way to move forward at a pace that is manageable for the family."

75% of participants with mental health concerns are accessing treatment

**IOO%** of participants are connected to cultural supports

**IOO%** of participants have an improved living situation

**63%** of participants were connected to new services


**75%** of participants with mental health concerns are accessing treatment
