Cassie subdivision is a unique place to live and enjoy lake activities. Lake Buchanan is one of the most beautiful lakes in Texas and offers a variety of activities for the individual as well as families.

The Cassie POA board has regular meetings on the 3rd Thursday of every month. The meetings begin at 6:30 p.m. at the Cassie Community Center on FM 690 and usually conclude by 8:00 p.m. If members have matters to bring before the board, we will address those matters first so the members can leave when they wish.

It has been brought to the board that many new Cassie Residents may not be aware of the State Law against driving in river and lake beds. This means that driving parallel to the water's edge or shoreline is prohibited. Such motor vehicles include dirt bikes, 4-wheelers, ATV/UTV's, golf carts and other off road vehicles. Many homeowners have water pipes running from the lake to their property.

Please remember to contact the board for approval prior to new construction or additions to current structures, garage, gazebo, fence or boat dock. You may do this through our website at cassiepoa.org. "contact us" section.

The board has two Director openings beginning July 1, 2022. If you are interested or know someone who is, please contact us through the POA website, contact one of your board members, or attend the annual meeting.

If you haven't supported your Cassie POA with your dues, please do so as soon as possible. Our POA operates only through the dues collected from property owners. Dues are utilized for maintenance on the boat ramp, Cassie POA owned road repairs, mowing access areas and all entrances, liability insurance for POA properties and property taxes.
