The March Bank statements have been reconciled.

As of March 21, 2024, there was a balance of \$36,549.08.

Since my last report there have been 2 deposits.

a. One for \$750 and one for \$825. A deposit for \$150 was not filled out correctly and returned by the bank. \$75 was for past due's, \$1200 for current year dues and \$300 for next year's dues

Since my last report there have been 5 checks written totaling \$2989.06.
