New Business

- 1. Approve boat dock at 506 N. Chaparral Discussion was held re: extending dock below the 1020 line; our guidelines are identical to those of the LCRA and we need the definition of "design elevation" and let the homeowner know that the board requires it to be at 1020'; it was agreed that we need to get more information, including the lighting plan on paper before we approve.
- 2. Approve retaining wall at 714 S Chaparral discussion was held on how high and how long, homeowner has not decided on building materials but as the existing wall is inside platted area and is the end of the property we are not concerned with where it is; Vesta made a motion to approve, it was seconded and approved.
- 3. Approve dredging 420 cubic yards behind 630 716 S Chaparral discussion was held on those homeowners dredging then placing the dredged material on one of their lots; LCRA does not require a permit and has no problem with where they want to put the material; Bill motioned to approve, it was seconded and approved.
