Minutes from the March 25, 2021 meeting were reviewed and approved

Treasurer's report was read and accepted. As of May 20, 2021 there is a balance of \$32,397.24; there are 204 paid members for the year 2020/21.

## **Unfinished Business:**

- 1. Need to fill 3 board positions Kenna, Patty, and Shelley confirmed they will continue on the board; there are three additional positions that need to be filled.
- 2. Homeowner at 4300 FM 690 Update Homeowner called Kenna and made an agreement that he will have 30 days to comply. Kenna will stop by and check progress then report to us after the 30 days.

## **New Business:**

- Approve house plans for 102 Stirrup Plans and plat were reviewed; homeowner
  has been informed that as only this year's dues have been paid, technically he is
  not "in good standing"; the lot is in the son's name, house being built by mother;
  Vesta motioned to approve, seconded and approved.
- 2. Approve Newsletter Discussion held on content, changes made to second paragraph. Discussion held on the need to change the sign at boat ramp and changing the phone number posted, with maximum cost expected of up to \$50.00; Bill motioned to approve change, it was seconded and approved. Discussion was held on adding "donation" to second invoice and adding "application" to invoice.
- 3. Amend Bi-laws and Rules and Regs Discussion was held about by-laws needing to be reviewed every 10 years and it has never been done according to past POA presidents. Bill and Hauke suggested forming a by-laws committee to research, then hire an attorney to figure out exactly how and what to change. Bill made a motion to approve, it was seconded and approved.
