## STIVER TO CONTEND FOR SENATE SEAT

David Stiver, a long-time Republican Party activist and resident of Colorado today announced his candidacy for the office of Colorado State Senator, District 10. Stiver sought the seat in 2020 but was denied access to the ballot via what can only be a questionable and carefully orchestrated maneuver by insiders and the Colorado Courts.

Stiver officially filed his Candidate Affidavit with the Colorado Secretary of State on December 29, 2023.

When asked why he was running Stiver said, “This was a race that I began in 2020 during the Emergency Rules and COVID19 lockdowns.”

As a candidate, Stiver filed a formal complaint with the Colorado Republican Party Executive Committee (EXCOM) and the Colorado Republican Party State Central Committee. Upon hearing the evidence both entities OVERWHELMINGLY sought to have Stiver added to the 2020 Primary Ballot. Stiver’ case went to the Colorado Court of Appeals and the Colorado Supreme Court. Both of which denied him access.

“As an athlete and long-distance runner, my coaches always said to me. You will never know just how good of an athlete you will be if you quit the race. This campaign is about continuing what I already started – BUT WAS DENIED. With that I have walked over three million steps and run over 1400 miles in the past 15 months in preparation. To fully represent the citizens of Senate District 10, El Paso County, and the entire state of Colorado.”

When asked what committees he would like to serve on, Stiver stated the following:

“I want to be on what I call the ALPHABET COMMITTEES. Appropriations, Budgeting (Joint Budget Committee – JBC), and Finance. In these tough inflationary and regulatory times, we need folks in office who have a firm grasp of accounting, economics, and finance.”

Stiver has not been sitting idly waiting for things to do. Over the past several years he has been active researching and testifying before several Colorado agencies. These include the Colorado Clear Air Commission, the Colorado Department of Public Health and Environment, and the Colorado Oil and Gas Commission to name just a few.
