1. What will guide your decision making in the role you're seeking? How will you hold yourself accountable? (Example: if you are running as a legislator, how will you decide whether to vote in favor or against the bill? Where does your accountability come from?)

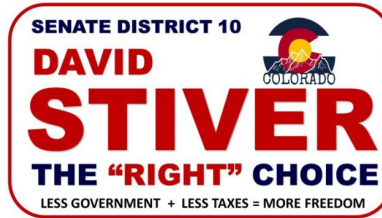
RESPONSE: Does it promote INDIVIDUAL LIBERTY as outlined in the Declaration of Independence, and the 14th Amendment of the United States Constitution. LESS GOVERNMENT + LESS TAXES = MORE FREEDOM (LIBERTY)? As well as my Christian/Biblical values. My party may abandon me. However, **My CHRISTIAN VALUES and PRINCIPLES never will.**

2. Why are you running as a candidate in Colorado and what do you feel you can bring to the office you are considering?

RESPONSE: To represent the UNHEARD VOICES of Colorado Citizens. Via the following:

- a. **GOVERNMENT OVER-REACH** and the **ADMINISTRATIVE STATE** (the Fourth Rail of Government). Colorado bureaus, agencies, departments, boards, and commissions function with TOO MUCH AUTHORITY and TOO LITTLE OVERSIGHT. - b. **TAXATION.** Imposing fees, whether legislatively or administratively, that circumvent the Taxpayers' Bill of Rights (TABOR) is unconstitutional. Redefining a FEE, which looks like a tax, walks like a tax, and talks like a TAX. EXAMPLE: Justice Roberts creatively REDEFINED "Obama Care" as being a TAX. The Colorado Supreme Court has REDEFINED TAXES to REPRESENT FEES to circumvent TABOR. Anytime a citizen must "OPT OUT" of a government-imposed service (by any other name) it is a TAX and a SUPPLEMENTAL REVENUE GENERATION SCHEME.

SUPPLEMENTAL:

Clerk and Recorder: Updating voter rolls. I will introduce legislation to require that the copies of any Property Deed (for the sale and/or transfer of property) recorded within the records of the Clerk and Recorder are recorded, documented, and copies disseminated to the Elections Department for purposes of identifying individuals who have moved from their existing household. Will this solve all voter registration and/or verification issues? No. For example, in the 10th Senatorial District there are:

15,358 – Inactive (Undeliverable Ballots)

4090 – Inactive (Returned Mail)

Reviewing the physical address information is much more efficient and cost effective than mail forwarding, which is only temporary (six months), and highly inaccurate/unreliable.

Digital Technology: The Colorado Courts refuse to accept electronically generated documents as evidentiary materials unless they have been verified and/or corroborated with eyewitness testimony. This includes Email. Digital technology may be intercepted, modified, and manipulated. The failure with the electronic systems is due to the fact the Tabulator and the Adjudicator DO NOT ALWAYS RECONCILE. Without a POLL BOOK and a PAPER TRAIL verification is impossible. The system uses a simple 6% accuracy model is derived from Generally Accepted Accounting Practices (GAAP) that considers sampling and a rate of 6% or less to be de minimis and/or insignificant. If the courts will not allow the use of technology wherein there is NO GUARANTEE of delivery because there is not a PAPER TRAIL? Why are we using the USPS to deliver paper ballots when there is not a GUARANTEE OF DELIVERY?

B). Do you believe the 2020 Presidential Elections were stolen?

RESPONSE: YES.

Ms. Griswald, to increase voter participation, mailed out over 87,000 ABSENTEE BALLOT APPLICATIONS with SAME-DAY REGISTRATION voter packets. The lists utilized were not from voter rolls, but merely general marketing lists. In an OUT-OF-COURT settlement with Tom Fitton and Judicial Watch, Ms. Griswald agreed to remove thousands of names from the voter registration rolls. The problem with VOTER INTEGRITY is that once crimes have

6. Do you believe there was an insurrection on Jan 6? Why or why not?

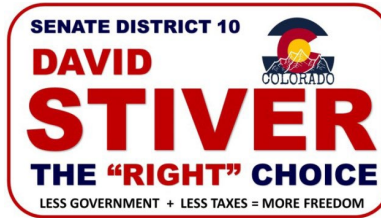

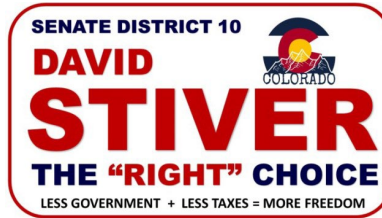

benefits while they earned a sustainable living. This included Food Stamps, Welfare, and Housing Assistance. The concept was simple. As wages increased, government benefits decreased. Over time, various Congresses have changed the program and costs have escalated. Social entitlement programs In Fiscal Year 2022 the federal government spent approximately \$1.19 trillion on over eighty different programs.

- **Public School Education/ Department of Education/ School Choice:** Although this is a state level office, I fully support ABOLISHING FEDERAL INVOLVEMENT IN EDUCATION. As a former chair of the D-11 District Advisory Accountability Committee (DAAC) Budget Committee I learned that THERE ISN'T A SOCIAL PROGRAM that government (public) schools will not voluntarily engage in as long as there is a funding mechanism attached to it. Thus, if the Federal Department of Education pushes CRT, DEI, ESL, Gender Dysphoria and Gender Modification Programs, the schools will voluntarily SIGN UP and push the left's agenda.

Using our schools as the CATALYST, the Colorado Department of Human Services (CDHS) has distributed a Transgender & Gender-expansive Youth Bill of Rights. Under this document, published by the Colorado Department of Education (CDE), "Youth have the right, WITHOUT PARENT OR GUARDIAN CONSENT...." 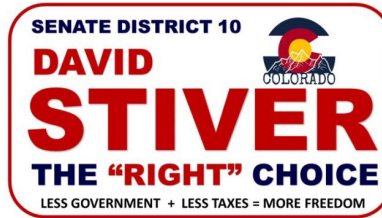
8. Have you ever read the Constitution?

Most recently, and rarely covered by the media, took place on February 20, 2019. *Timbs v. Indiana*. (9-0). In *Timbs v. Indiana*, Justice Ruth Bader Ginsburg wrote the MAJORITY OPINION. *Timbs v. Indiana* deals with CIVIL FORFEITURE and CIVIL PENALTIES as part of a penalty. The eighth amendment. However, the Supreme Court of the United States (SCOTUS) ruled that if a STATE AGENCY confiscates a person’s property WITHOUT DUE PROCESS, the agency is not no longer immune and as such cannot assert it rights under the 10th amendment. Rather, the state must follow, the 4th, 5th, 8th, and 14th amendments.

9. Do you believe we were founded as Christian nation and those who serve in public office must seek to carry about the Scriptural mandates?

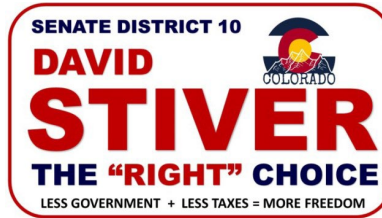

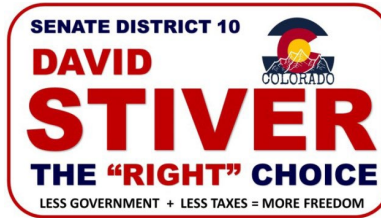
17. What does integrity mean to you, and what main components do you feel secure integrity both personally and nationally?
