



## TWISTED ALLIANCE RC WAIVER AND RELEASE OF LIABILITY

In order to participate in a ride or other event with TWISTED ALLIANCE RC you MUST sign this waiver **whether you are a rider or a passenger.** This waiver shall apply to your participation in any and all events from and after the date signed below and shall not expire.

### **Release of Liability, Waiver of Claims, and Assumption of Risk Agreement Please read carefully!**

I am aware that riding a motorcycle involves risks, dangers and hazards in addition to those normally associated with the operation of motor vehicles. I acknowledge and accept that risk exists while participating in motorcycle riding, including **group** riding and in consideration of my desire to participate in such activities I hereby for myself, my heirs, executors, administrators, or personal representatives including parents or guardians, knowingly and voluntarily enter into this Waiver and release of liability. I hereby waive any and all rights, claims or causes of action of any kind arising out of my participation in the activity/event.

I understand that I am voluntarily participating, and at my own risk, and I hereby agree to the following:

1. To ride responsibly and obey all rules of the road.
2. That I am in good physical and mental condition to successfully and safely operate my motorcycle or be a passenger during any TWISTED ALLIANCE RC ride or event.
3. To maintain a valid motorcycle license and the state mandated liability insurance covering any motorcycle or vehicle that I will be operating during a TWISTED ALLIANCE RC, ride or event.
4. To waive any and all claims that I have or may might have in the future against the organizers, leaders, officers, members, ride leaders, or road captains of TWISTED ALLIANCE RC.
5. To release forever, any and all liability from organizers, leaders, members, road captains, guests and any participant of TWISTED ALLIANCE RC, for any loss, damage, expense or injury, including death, that I may suffer or that my next of kin may suffer as a result of my participation in a TWISTED ALLIANCE RC ride/event; due to any cause whatsoever, including negligence, breach of contract, or breach of any laws or other duty of care, on the part of Twisted Alliance RC.
6. I understand that photographs may be taken throughout any event and may be used for club purposes and on the web page/social media. These photographs belong to TWISTED ALLIANCE RC and the person taking the pictures.
7. If I bring a minor(s) to any ride/event, I as parent or guardian of such minor(s), on my behalf and on behalf of my minor(s), I release forever, any and all liability from organizers, leaders, members, road captains, guests and any participant of TWISTED ALLIANCE RC, for any loss, damage, expense or injury, including death, that I may suffer or that my next of kin may suffer as a result of my participation in a TWISTED ALLIANCE RC ride/event; due to any cause whatsoever, including negligence, breach of contract, or breach of any laws or other duty of care, on the part of Twisted Alliance RC.
