- 8. Are there #beneficiaries of the trust whom you now may want to disinherit?
- 9. Conversely, are there persons you omitted from the trust whom you now want to name as beneficiaries?
- 10. Are there any changes you want to make to the trust?
- 11. Have you created a trust for your BFF—your dog, cat, or other pet?
- 12. Are there #charities you now want to gift that are not remembered in your trust?
- 13. Conversely, are there charities you remembered in your trust whose gifts you now want to change or remove entirely?
- 14.Do you now want to change the distribution of shares you have previously given to one or more beneficiaries in your trust?
- 15. Have there been changes in the law that may affect your trust?
- 16.Is your trust more than 3 years old? Trusts—and indeed all your estate planning—should be reviewed every three years to keep it up to date.
- 17.Do any of your beneficiaries now need #guardians/trustees to manage their affairs

- 18.Are any of your beneficiaries receiving #Medicaid or other government assistance? Or might one or more of them need Medicaid or other government assistance in the foreseeable future?
- 19. Is it possible that you or your spouse may need Medicaid or other government assistance in the foreseeable future?
- 20. Is your trust complete? Or are important provisions missing?
