_____ This kitten MUST be kept indoors. You agree not to allow this kitten to roam freely outside unless on a leash or accompanied by a responsible adult.

_____ This kitten is being sold as a pet only and is not for breeding. This kitten is to be spayed / neutered by the time he / she reaches 6 months of age.

_____ Kittens pure bred LIMITED TICA Registration papers will not be give until proof of spay/neuter has been provided to breeder.

_____ This kitten will not be sold, leased, given away, or abandoned to any shelter. If you are unable to continue care for this kitten , you should contact Chelsea at Hillside Bengals immediately.

_____ Buyer agrees to never vaccinate for FIP (Feline Infectious Peritonitis). The effectiveness of the vaccine has not been established and the Vaccine can cause the disease. Failure to comply will void all health guarantees (If one applies).

_____ All sales are final. There will be no cash refunds. Do your research on the Bengal Cat before agreeing to this purchase.

_____ This contract is a confidential agreement between above buyer and seller and is not transferable to any other parties for any reason.

_____ This is a legal binding contract, If this contract is breached in any way, Purchaser will owe the seller a fee of \$3,000US for breach of contract over and above the original price each and every time the contract is breached. Once the contract is breached, Purchaser is to surrender the cat/kitten back to the Seller without refund and at the Purchaser's expense with signed Transfer of Ownership. Purchaser agrees that if any legal action needs to be taken that all legal fees will be Purchaser's responsibility for both parties and it will be held in seller's current state and county of residence.

_____ Any and all disputes will be settled between Seller and Purchaser PRIVATELY and will NOT be aired in any public forum or any social media by either party.

Kitten is guaranteed against congenital defects for the period of **twelve (12) months from date of sale.**

The SELLER guarantees that at the time of sale the kitten is healthy, and was found to be free of any disease or congenital defects and/or the signs of such.

The BUYER assumes all responsibility for kitten once in possession of it.

We require that the BUYER is to take the Kitten to their state licensed veterinarian within **3 business days** after the purchase date, at the expense of the BUYER. If I don't receive proof of vet visit within 3 business days the health guarantee will be null void.

Cat **MUST** be secluded ; not introduced to other cats for at least **10 days** upon arrival. If you introduce him/her to other cats before 10 day period and he/she or one of your other cats end up with some kind of illness , Seller will not be held liable and this guarantee will be null void.

The SELLER is not aware of any health issues including, but not limited to, upper respiratory infection or diarrhea at the time the Kitten leaves the SELLER's premises. However, it is NOT uncommon that the stress from the change in environment may cause the Kitten to "break" with an upper respiratory infection or any other infection, even though the Kitten showed no clinical signs of an infection when it left the SELLER's premises. This is why it is important for the Kitten to be checked out within **3 business days**. When a kitten goes into a new home, this can sometimes result in diarrhea/loose stools a few days after arrival.

If the kitten is found to have a congenital defect within these twelve (12) months and results have been provided by licensed veterinarian, BUYER must contact the SELLER immediately. Upon the return of the Kitten at the expense of the BUYER, it will be replaced with another cat/kitten of equal value.

The cat cannot under any circumstances be returned if it has been exposed to another cat which has not been tested and currently free of the following :FIP, FCoV, FP, FELV, FIV, Giardia, Feline Herpes Virus, or Feline Calicivirus .

There are NO guarantees against transmittable diseases/viruses such as but not limited to; FIP, FCoV, FP, FELV, FIV, Giardia, Feline Herpes Virus, or Feline Calicivirus UNLESS kitten/cat has been tested and had positive results at very FIRST vet appointment (**within 3 business days of going to new home/before being introduced to any other pets**) as we are a health tested cattery and have never tested positive for any of these. **Results will be verified with your licensed veterinarian prior to any action taken** Please note any of these viruses/diseases can also be picked up at your vet or any other location where other infected cats have been.

Purchaser agrees never to vaccinate this Kitten against FIP (Feline Infectious Peritonitis). The effectiveness of the vaccine has not been established and the vaccine can cause the disease. Failure to comply will void entire health guarantee.

This health guarantee does not cover coccidia outbreak. If kitten shows any signs of this take him/her to vet for treatment IMMEDIATELY as it is deadly in young kittens.

Seller strongly advises buyer against the use of Ketamine anesthesia during spay/neuter of your kitten. There have been many reports of bengals dying or developing life threatening issues after use of ketamine. It is the buyers responsibility to talk with their vet and make sure Katamine is not used. We will not be held responsible for any issues that should arise after Ketamine being used.

Should the Kitten die as a direct result of a congenital defect or HCM, the cat will be replaced ONLY if an appropriate necropsy is performed by a licensed vet and a vet's certificate is provided proving that the cause of death was directly related to a congenital defect or HCM. A replacement will be made with a cat of comparable quality and value, as available, at the discretion of the breeder. All proving documents provided by vet must have matching microchip numbers to said kitten (if one applies).

SELLER warrants that the Kitten was completely litterbox trained when it left the premises. However, the new surroundings may confuse the Kitten and may result in improper elimination. BUYER needs to ensure that the Kitten knows where its new litterbox is located, and SELLER recommends that BUYER uses the same type of litterbox and litter used at the SELLER's premises to avoid confusing the Kitten.

At the time of sale this kitten corresponds to the class Breed, and is registered/can be registered with TICA . (The International Cat Association).

BUYER is responsible for any and all shipping fees should they be required.

In the event someone in the home should develop allergies (within 7 days of going home only , no exceptions) a 50% refund of Purchase Price (excluding shipping costs if applicable) will be given.

THERE WILL UNDER NO CIRCUMSTANCES BE ANY REFUNDS Should a kitten need to be returned for ANY other reason other than allergy development (within first 7 days of receiving the kitten), the kitten must come back to breeder and no refunds will be given. You will only have an option to receive another kitten of equal value, when available, at sellers discretion when you are in a better situation to care for one.
