Hello Comrades! Here is some good news from the Ralph H. Johnson VA Medical Center in Charleston.

Veteran do not live in a vacuum. They, like anyone else, often face struggles in their relationships with their spouses and children. Dealing successfully with those struggles through a patient-family centered approach is the goal of the Couples and Family Therapy clinic at the Ralph H. Johnson VA Medical Center.

This little known VA therapy option is available to any Veteran and his or her spouse or family members for issues related – or unrelated – to their military service. The Couples and Family

Therapy Clinic offers a variety of treatment options to best meet the couple's or family's need including Integrative Behavioral Couples Therapy and Behavioral Parent Training. There is also help for couples dealing with substance use disorders or families learning to cope with a serious condition such as traumatic brain injury or Post Traumatic Stress. Therapy sessions, which normally average six to 12 sessions, are available in-person, through Tele-Mental Health to a VA clinic, or through Home Based Tele-Mental Health. The Couples and Family Therapy Clinic, in conjunction with VA Chaplain Service, also offers marriage enseminars retreats richment a n d throughout In general, couples who engage in therapy experience greater marital satisfaction, closer emotional bonds, greater ability to work together and less emotional avoidance. Family therapy is effective in several areas including addressing general child conduct issues, child aggression, family problems, improving communication and problem For more information on Family and Couples Therapy, call (843) 577-5011 ext. 5395. Veterans may also discuss a referral to the clinic with their provider.

And, a reminder that today is a good day to ask a qualified veteran to join our VFW. We are stronger together.

First, Thank You all for your support in my election to Department Surgeon. I really appreciate it.

Remember that Hurricane Season started on June 1st, and we have had the weather to remind us. Be prepared by knowing your escape route and keeping enough water, food, and medications for at least 3 days in case you are stuck at home. Prepare by having batteries available for light and radio in the event of power outage.

For those who do not know the SOI is the time when program information and any changes from VFW National are

passed to the posts. This meeting and all District and Department meetings are open to all post members. We invite you to come, share ideas and hear what goes on at the District and above.



Are you eligible for combat related special compensation?

FORT KNOX, Ky. — Have you heard about a retired veteran's program called Combat-Related Special Compensation (CRSC)? If you haven't, don't worry, you are not alone. If you are familiar with CRSC, it's likely you're still not sure if you qualify or how retired veterans can apply for this benefit. To shed light on the program, the Army CRSC office at Fort Knox, Kentucky offers the following helpful tips and information.

First, potential applicants should understand that CRSC is a Department of Defense (DOD) program, not a Department of Veterans Affairs (VA) program, and is authorized under 10 U.S. Code § 1413a. CRSC is a form of concurrent receipt paid monthly to eligible military retirees. In other words, CRSC restores military retired pay that is offset when a retiree accepts compensation from the VA for a disability or condition that can be directly linked to a combatrelated event as defined by the CRSC DOD program guidance. The CRSC benefit allows eligible retirees to concurrently receive an amount equal to or less than their length of service retirement pay and their VA disability compensation.

Retirees must meet all of the following criteria to be eligible for CRSC:

- Must be retired and receiving military retired pay.
- VA must have awarded 10 percent or greater service connected disability for a condition that meets the combat related definition as defined by CRSC DOD program guidance.
- Must have a VA waiver (VA Form 21-651, MAR 2005) in place for by-law reduction of military retired pay in the amount of the VA disability payment.

Eligible retiree categories include those who have 20 or more years of service, or a medical retirement under Chapter 61, Temporary Early Retirement Act (TERA), or Temporary Disabled Retirement List (TDRL).

A combat-related injury is one that can be attributed to:

- Simulated war training (e.g., combat obstacle course)
- Hazardous duty (e.g., underwater diving, parachute duty)
- Instrumentality of war (e.g., military vehicle rollover during a training mission)
- Presumptive Disabilities (e.g., Agent Orange, mustard gas)
- Armed conflict (e.g., gunshot wounds, shrapnel wounds, punji stick injuries)

Due to the volume of applications received, the Army's CRSC program is experiencing an average 10-month claims processing cycle. CRSC applicants should note that an uncorroborated statement in a record that a disability is combat-related will not be considered determinative for purposes of meeting combat-related program standards; documentation verifying the cause of the disability is required. The CRSC program validates your submitted 10 information against your personnel records, available military medical and VA records in making eligibility determinations. Therefore, you only need to submit those documents that directly support your claim that are not already found in your official record. Submitting non-related documentation (i.e., your entire medical history) will only slow the process and increase your wait-time. Finally, electronic submittal is the best, lowest cost, and most efficient way for you to submit your claim.
