ADULT / YOUTH DIVISION ALL PRIZE FEES AWARDED TO THE YOUTH BOWLERS AS A SMART SCHOLARSHIP

The Metro Phoenix USBC Association 2 X 2 Mixed Doubles Tournament is open to all current USBC certified members

- 1. ALL PARTICIPANTS MUST HAVE A CURRENT USBC Membership card. Membership will be sold at the tournament site.
 - a. Doubles teams must be comprised of one male and one female bowler
 - b. Members of any professional bowlers' organization (PBA, PWBA) shall be limited to one (1) member per doubles team.
- 2. A bowler may bowl multiple times but cash only once in each division, handicap or scratch, with the same partner.
- 3. Two games will be bowled on one pair of lanes. Lanes assigned at time of check in by Tournament Director
- 4. Entries will be accepted on site. Bowlers may bowl anytime between 10:00am and 4:00pm. Last start time will be 4:00pm
- 5. Averages:
 - a. Entrants shall use their highest 2018-19 league (winter) average.
 - b. If no 2018-19 book average is available, the bowler will use the highest average of 2017-18
 - c. If no 2018-19 or 2017-18 book, the bowler will use the highest 2019 summer league average of 21 or more games as of 8/10/2019. Each bowler must provide a copy of their league sheet from 8/10/2019
 - d. If none of the above, the bowler will be assigned an average of 230.
 - e. Bowlers with a Sport/Challenge average, will have their average adjusted, using the USBC Average Adjustment Chart. If the adjusted average is higher than the standard average the adjusted average will be used.
 - f. USBC Rule 319(a) is applicable for this tournament. If at the time of bowling the current season average, minimum of 21 games, is 10 pins or more pins higher than the 2018-19 league average (winter), the current average must be used.
 - g. USBC Rule 319(c) dealing with AVERAGE ADJUSTMENTS (RERATING) Bowlers whose tournament average for the last 3 tournaments, minimum of 21 games is 15 pins or more, higher than the 2018-19 league average (winter or summer), will be re-rated to their tournament average.
 - h. USBC Rule 319 (d) and 319€ will not apply.
- 6. Handicap is based upon 90% of the difference between the bowler's average and 230, with no negative handicap.
- 7. Tournament participants are not allowed to practice within two hours of squad time.
- 8. Prize fees will be returned 100% with a minimum ratio of 1 to 5 in each division.
- 9. All prize fees for the Adult / Youth Division will be awarded as a scholarship for the youth. They will be deposited into SMART.
- 10. No entry fees will be returned after practice has begun.
- 11. No unreasonable delay in the progress of any game will be permitted (USBC Rule 11).
- 12. All decisions of the tournament committee will be final unless an appeal is filed with tournament management (USBC Rule 329).
- 13. It is not necessary to report previous prize winnings.
- 14. One-lane courtesy, should be observed.
- 15. Tournament/Association management reserves the right to cancel any tournament due to lack of entries/participation by the closing date of the tournament, or as deemed necessary. All entries with fees would be returned to the team captains.
