This is not mandatory, but is optional and can help you decide the perfect cake flavors for your wedding cake!



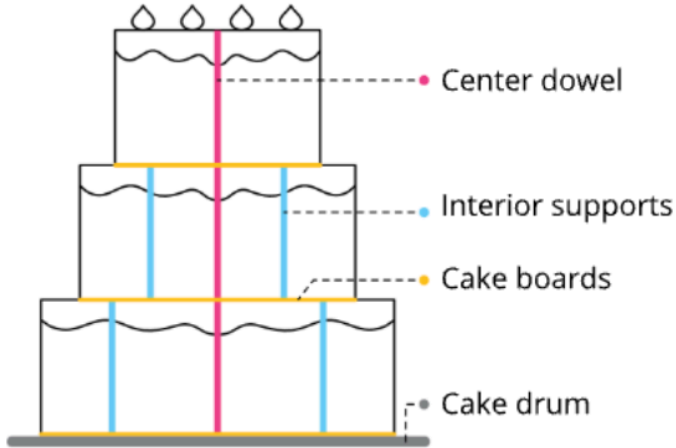
Our tasting boxes are a great way to try cake flavors, and get to mix and match them with fillings & frosting flavors as well!

Cake Disassemble Guide

For Tiered Cakes



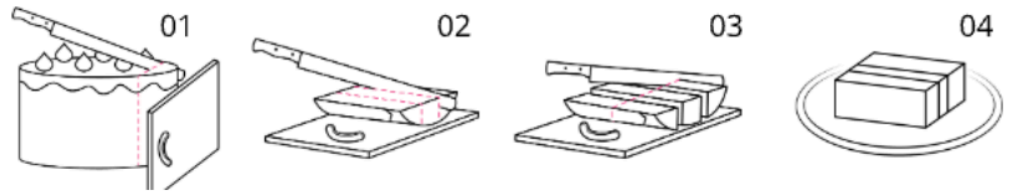
Your cake is assembled using multiple food safe supports & dowels.

Each tier is an individual cake, on its own board.

Use cake server to separate top tier. Then slide your fingers under the board and lift it straight up. Once the top tier is removed you can take out the center dowel.

Repeat this process to separate the remaining tiers.

Pricing

A deposit is required to secure your wedding date. Your order will not be guaranteed until that deposit is made.

The deposit amount will be 25% of your total order price. This deposit is nonrefundable.

The remaining balance will be due 1 month before the wedding date. The deposit and final payment will be made through an online invoice via credit/debit card.

Any late payments may be subject to late fees. For cancellations within 1 month of the event, the entire amount of order is still owed.

Delivery:

There is a **minimum delivery fee of \$30.00**, increased fee is dependent on location of deliver and the size of the order

Cake Design:

Some cake design options that may up the price include fondant, intricate piping designs, cake toppers, fake flowers, fresh flowers, etc.

Contract

This Wedding Cake Contract is entered into by Olicakes Baking Company and _____ (the "Client"). Olicakes Baking Company agrees to deliver cake(s) as agreed upon and on time. The client agrees to pay Olicakes Baking Company for the production and delivery of cake(s). The following terms and conditions apply:

- A 25% deposit is required to secure the event date after taste testing and is non-refundable. The remaining balance is due 1 month before the delivery date.
- Payments made after the due date are subject to late fees.
- Payments will be paid via credit/debit card through online invoice unless otherwise agreed upon.
- For cancellations within 1 month of the event, the entire amount of the contract is still owed to Olicakes Baking Company.
- Any changes to the order are subject to availability and must be made in writing no later than one month before delivery and may incur additional charges.
- Client assumes full liability and responsibility for the condition of the cake once it leaves Olicakes Baking Company's possession.
- Client is responsible for providing an appropriate and secure environment for the cake(s), i.e. a sturdy table and optimum room temperature of 75 degrees or below.
- The size of the tiers will be adjusted to accommodate the correct number of servings based on an industry-standard slice of approximately 8 cubic inches, 4 inches high, 1 inch wide, and 2 inches deep.
- Olicakes Baking Company is not responsible for the shortage of cake due to incorrect guest counts or failure to cut industry standard-sized slices.
- Olicakes Baking Company reserves the right to use any photographs of the finished cake for promotion without compensation.
- Olicakes Baking Company promises a product of high quality and service but is not liable for unforeseen circumstances, including but not limited to inclement weather, transportation problems, accidents, and other causes beyond reasonable control.
