

# Annual Meeting - Dredging Update

Wayne Stanley reported 19 bags of material were filled during the dredging of the lake. Dredging was completed below the budget of \$425,000. Future plans to reclaim the material in the silt bags include looking for someone to take the material and possible usage at the point to smooth out the field. Approximately \$10,000 has been allotted for dredging reclamation. The timeframe to get all of the silt bags and material cleaned up is early summer. # Annual Meeting - Lifeguard Update

Carl Hatfield reported that there would be six lifeguard candidates this year. Their first day will be Saturday, May 28th. All lifeguards are certified by the American Red Cross. (We still have open positions for lifeguards this summer. Please contact Carl Hatfield for more info.)



### Annual Meeting - Clubhouse Rental Update

JoDee Decker reported that the Clubhouse rentals are running smoothly. In 2021 over \$4,000 was raised. YTD collection for 2022 is over \$1,800.

# Annual Meeting - Financial Update

Jeff Owens reported that Stockholders that are in arrears are being actively pursued our attorney. The Lake has already settled with one Stockholder. There are still approximately \$80,000 in arrears and of that amount, approximately \$70,000 has been turned in to magistrate court. Guenter Metzger feels that our attorney is moving in the right direction while doing things legally. The Lake wants to avoid any legal ramifications from collections. The current Lake assessment has expired. Jeff Owens read the new assessment proposed by the Board. \$200 per year would raise approximately \$324,000 in 10 years for major projects. The motion to create a new \$200 per year assessment was passed by the assembly.

# Annual Meeting - By-Laws Update

Michael Arnold moved to adopt the proposed By-Laws revision which was included in the Annual Meeting packet. After some heated debate as to the legality and right of anyone to change the By-Laws, Bonnie Thomas went on to summarize the changes to the assembly. The vote was unanimous for passing the By-Laws revision.

Our newest Maple Lake Club Board members are Chris Cleghorn and Jack Merinar. Returning for another term are Scott Anderson and Michael Arnold. Christy Cleghorn has been appointed as Club Secretary after Suzie Zimniski's retirement. Thank you Mrs. Z, for your 13+ years of service.
