Residency Verification Form

This form has been provided to assist the Big Pine Paiute Tribe to verify the location of your residence. Only Big Pine Paiute Tribal members who reside within the Big Pine Paiute Reservation or who live within a 7 mile radius of the township are eligible to receive the IGRSTF payment according to Policy Section 1. Eligibility Status (b) The Tribal Member must maintain residency on the Big Pine Reservation thirty (30) days prior to the approval of the gaming revenue list. Residency verification is a Tribal Member's responsibility & falsification of information provided on this document will be grounds for immediate cancellation of eligibility to the subsequent IGRSTF payment. In cases where residency is questionable, the Big Pine Paiute Tribal Council can investigate by making a home visit. Please provide the information requested below so that a sound decision regarding your residency status can be made.
