a.) Shirley Spratt-Status of House Left In Trust

Ms. Spratt submitted a copy of the "OVIHA Document, CAL 98-1 Designation of Successor by Homebuyer" form, which states her as the Successor for her late Father, Michael Spratt Sr.'s house. The OVIHA document was signed by her Father on April 20, 1981 and the house is located at Block 17, Lot 12.

In the 1980's the house and land was designated to Mr. Clarence Spratt by tribal resolution and he currently resides in the home. This Tribal Council is unclear of the timeframe this was approved by previous Tribal Council Members and therefore, this Tribal Council requests this issue be tabled to September 3, 2008 to allow Staff to research past minutes/resolutions motioned for approval.

b.) Tom Moffett-Quit Claim Deed and Temporary Use Permit-Not Present.

c.) Lorraine Barlow-IGRSTF Distribution

Ms. Barlow was denied a IGRSTF distribution check and was present to voice her disagreement on Tribal Council's decision and submitted her Release Form from Inyo County Jail. Tribal Council informed Ms. Barlow that the new Gaming Distribution Policy will be approved at the General Council meeting on September 24<sup>th</sup> in regards to the 30 day incarceration as stated in the policy. However, that won't be in effect until it is approved by General Council, thus the reason Tribal Council concluded that she be deemed ineligible. Tribal Council will discuss her issue and inform her of their decision.

d.) Ryan Escalera-IGRST Distribution

Mr. Escalera was present to inform Tribal Council he has been living within the 7 mile radius, however failed to submit a voter's registration once he returned. He submitted letters from the owners of the residence he resides in along with employment applications as proof of being in the Big Pine area. Tribal Council will also discuss his issue and inform him of their decision.

e.) Harold Pierce, Jr. Trailer House Inspection & Land w/EPA Monitoring Well Block 18, Lot 13- Not Present.

f.) Bobbie Sue Miller-Requesting to Move Mobile Home on Block 10, Lot 21

Ms. Miller was present to ask if she could move a mobile home on her lot for her grandchildren's father. He needs a place to stay, no rent would be paid. Tribal Council informed Ms. Miller of the moratorium on bringing trailers on the reservation for non-

tribal members and that the trailer would have to pass inspection, and a water and sewer hookup would need to be completed. Ms. Miller was inquiring on what would be need to be done. Her second question was if she could move a travel trailer up here for herself. Tribal Council's concern would be of environmental issues regarding waste as there is no water/sewer hookup and if she took care of that it would be fine.

Action Item Two: Requesting a date to set for the meeting with NAWS. Tribal Council agreed this is not an actual action item for motion, but agreed to meet on September 17, 2008 in Lone Pine for the Leadership Meeting.

Rescheduled General Council meeting to September 11, 2008.

b.) DRAFT Policy Emergency

Tabled-Tribal Council will review and approve at next Tribal Council meeting on September 3, 2008.

c.) Indian Gaming Revenue Shares Trust Fund Distribution Policy

Tabled-to next Tribal Council meeting, September 3, 2008.

d.) Sylvia Cortez-IGRSTF Distribution

Ms. Cortez submitted a letter from the owner of the residence that stated she does not reside in the residence. Ms. Cortez is appealing Tribal Council's decision and believes she should receive a IGRSTF check. Tribal Council will review and discuss this issue and inform her on their decision.

e.) Temporary Use Permit List Update

Tribal Council discussed revisions to be made to the TUP form and changes will be made and approved at the next tribal council meeting on September 3, 2008.

f.) Temporary Use Permit Harriet Smoker with Joanie Hanson-ID Submitted

This request was submitted to Tribal Council again as the previous application did not include Identification/Driver's License from Ms. Hanson. Ms. Smoker and Ms. Hanson would also need to submit a waiver of the home releasing the Big Pine Paiute Tribe of any liabilities as in the past there was a rodent problem with the home. Tribal Council agreed to tentatively approve the TUP upon receipt of the waiver signed by both parties.

Motion by Cheryl Levine to approve the TUP contingent on submitted requests.  
Second by Carl Hernandez. 4 Ayes, 0 Nays and 0 Abstentions. Motion carried.

## g.) Jessie Archer (Burdick) Request for Conditional Enrollment Relinquishment from the Big Pine Paiute Tribe of the Owens Valley

Consensus from Tribal Council to compose a letter to Mr. Archer stating that the Big Pine Paiute Tribe's Enrollment Ordinance does not provide conditional enrollment relinquishment and Tribal Council will abide by the Enrollment Ordinance and not grant this request. Furthermore, Tribal Council would like to advise Mr. Archer of the new amendment that was approved by General Council that states that anyone who has relinquished their rights as a member of the Big Pine Paiute Tribe can not be reinstated.

Dear Mr. Archer:

The Big Pine Tribal Council held a meeting on August 21, 2008 and at that meeting discussed your request for a conditional enrollment relinquishment. Unfortunately, the Enrollment Ordinance approved by the Big Pine General Council on November 8, 1988 does not have a provision to offer a conditional enrollment relinquishment to tribal members. The Big Pine Tribal Council will abide by the Enrollment Ordinance and is not going to grant you a conditional enrollment relinquishment.

If you decide to pursue membership with the Bishop Paiute Tribe and relinquish your membership with the Big Pine Paiute Tribe of the Owens Valley, then the Big Pine Tribal Council would like to advise you that a new amendment has been approved by the General Council which states that anyone who has relinquished their rights as a member of the Big Pine Paiute Tribe can not be reinstated.

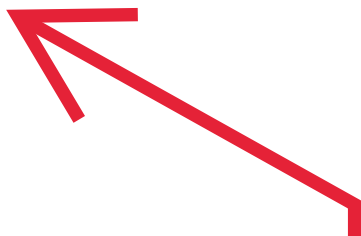


Dear Tribal Council,

Jan 18th, 2019: The Big Pine Paiute General Council reviewed Mrs. Huetter's appeal documents. All Big Pine Tribal members present then voted to uphold Mr. Archer's election to The Big Pine Paiute Tribal Council.



In June of 2023 (2 years after this resolutions was drafted in secret) Toiyabe Board Chairman Virgil "Dave" Moose directs Toiyabe staff to distribute this document to the entire Toiyabe Board of directors, in attempt to revoke Mr Archer's eligibility to receive healthcare services. This document is eventually added to Mr Archer's medical records without his knowledge or consent. Mr Archer also loses his "PRC" eligibily at this time and is not notified.

**WHEREAS,** The Big Pine Tribal Council is the duly elected governing body of the Big Pine Paiute Tribe of the Owens Valley, which is a federally recognized Tribe; and

**WHEREAS,** The Big Pine Paiute Tribe's Enrollment Ordinance No. 5 provides for an enrolled member to relinquish their membership and any benefits granted to them, so long as such member submits their request for relinquishment in writing; and

**WHEREAS,** Such documentation has been filed by Jesse Ray Burdick (a.k.a. Jesse Ray Archer) Rolle number 268 and enrolled member states his desire to relinquish his membership from the Big Pine Paiute Tribe of the Owens Valley, and

**WHEREAS,** The member had requested a "conditional relinquishment" and the request for "conditional relinquishment" was not approved at a Tribal Council meeting held on August 21, 2008, and

**WHEREAS,** The member is fully aware of the consequences of relinquishment and the consideration that he is no longer entitled to as a result of relinquishment of his membership with the Big Pine Paiute Tribe, and


**WHEREAS,** This is a permanent and binding resolution set as according to the Big Pine Paiute Tribe's Enrollment Ordinance No. 5, there is no stipulation for re-enrollment of a Tribal Member who relinquished their membership and there is no appeal process.

**NOW THEREFORE BE IT RESOLVED,** that the Big Pine Paiute Tribe of the Owens Valley is informing the Bureau of Indian Affairs of the relinquishment of enrollment submitted by **Jesse Ray Burdick (a.k.a. Jesse Ray Archer) Roll number 268, on July 18, 2008** and subsequently Jesse Ray Burdick a.k.a. Archer is not a member of the Big Pine Paiute Tribe from July 15, 2021, forward.



I have been an enrolled citizen of the Big Pine Paiute Tribe since I was a baby. I am a direct descendent of Janet Kaye Dondero and Vivian Stone. To be clear, I have NEVER relinquished my membership in this tribe.

I would like to officially request; 1) copies of all documents and records in my enrollment file and 2) copies of enrollment committee agendas dated from December 2018 to the present.

I would also like to request that no less than 3 enrollment committee members (including Taylor Richards and Tanya Spoonhunter) be present and in the room while my enrollment file is removed from the records room and copies are made. I would ask that either Taylor or Tanya physically handle my files.

Lastly, I would like to ask for any additional documents related to my enrollment appearing in official tribal resolutions or decrees.

I am making these requests in writing AND in person, directly to the enrollment committee because I believe that my enrollment files have already been inappropriately accessed, distributed and likely corrupted.

**Immediately after Mr. Archer presented this letter, Cheryl Levine (Enrollment Committee Chairperson) stated she would not provide Mr. Archer any documents from his enrollment file because a decision to dis-enroll him had already been made.**

**Mr. Archer stated he had received no communications or notifications whatsoever from Big Pine Tribe related to his enrollment status. Furthermore, the Committee Members who were present (T.Spoonhunter, T.Richards and C.Levine) stated Mr. Archer's name had not appeared on any Enrollment Committee Meeting Agendas or minutes.**

**Mr. Archer asked Chairperson Cheryl Levine to provide any official tribal documents or resolutions related to his enrollment. Mrs. Levine stated she would not provide any documents to anyone without approval from the Tribal Council.**

**\*\*\*At this time Cheryl Levine was the only Enrollment Committee member with keys and access to the locked enrollment file cabinets.**

Dear Tribal Leader

I am writing on behalf of the Big Pine Paiute Tribe of the Owens Valley to inform you of a recent change in tribal membership and affiliation for Jesse Burdick Archer. We kindly request that you update your records accordingly to reflect this change.

Jesse Archer was previously recognized as a member of the Big Pine Paiute Tribe of the Owens Valley. However, on August 21, 2008 the Big Pine Paiute Tribal Council confirmed Mr. Archer's relinquishment of enrollment on July 15, 2021 whereas the Big Pine Paiute Tribal Council approved and signed Resolution No. 21-12, to acknowledge and accept this disenrollment of Jesse Burdick Archer from the Big Pine Paiute Tribe of the Owens Valley. Furthermore, it has come to the Tribe's attention that Mr. Archer still acknowledging himself as a member of the Big Pine Paiute Tribe of the Owens Valley, as well as a representative of the Tribe. At this present time, let it be known by all, Mr. Archer is not affiliated with our Tribe either as an enrolled tribal member, employee, elected official or representative in any capacity.

In light of this update, we kindly request that you make the necessary amendments, updates or changes in your records and databases to reflect Mr. Archer's non-tribal member status accurately. It is important that their affiliation with our Tribe is updated, as this ensures the accuracy and integrity of your data and help avoid any future confusion and misrepresentation.

We would appreciate it if you could confirm the completion of these updates and provide us with any relevant reference number of documentation associated with the record amendments.
