Petition for the recall of the Snohomish County Sheriff, Adam Fortney, to the Honorable Garth Fell, Snohomish County Auditor

TITLE: We, the undersigned citizens and legal voters of Snohomish County, respectfully direct that a special election be called to determine whether or not Adam Fortney, Snohomish County Sheriff, be recalled and discharged from his or her office, for and on account of his having committed the act or acts of malfeasance or misfeasance while in office, or having violated his or her oath of office, in the following particulars: On April 21, 2020, Sheriff Fortney stated in a facebook post that he has not and will not enforce Governor’s Inslee’s “Stay Home -Stay Healthy” emergency proclamation. He reiterated his position at a press conference on April 22, 2020. This Statement: a. violates the sheriff’s statutory duties under RCW 36.28.010 and 36.28.011; b. constitutes performance of a duty in an improper manner; c. constitutes neglect or a knowing failure by an elective public officer to perform faithfully a duty imposed by law; and each of us for himself or herself says: I have personally signed this petition; I am a legal voter of the State of Washington in the precinct and city (or town) and county written after my name, and my residence address is correctly stated, and to my knowledge, have signed this petition only once.
