Introduction

This Cookie Statement explains how Vineland Partners PTE LTD, AEDP ("we", "us", or "our") uses cookies and similar tracking technologies when you visit our website: www.aedp.com. - **Targeting or Advertising Cookies:** May be set through our site by our advertising partners to build a profile of your interests.

We do not currently use advertising cookies.

- Ensure compliance with legal and regulatory obligations

Cookies are not used to collect personal data such as your name or email address unless you have explicitly provided such data to us via web forms.
