## Jan 7,2021

Averill Park School District collects PFOA, PFOS,4 dioxane samples from school wells as required. This is the first time this testing was done pursuant to new rules. Includes AP High, Algonquin, West Sand Lake and Miller Hill Elementary. Poestenkill and GW buildings not tested as these are supplied with municipal water.

## Jan 28, 2021

School opts to switch to bottled water for drinking and cooking only and sends notice to parents. ams-shows-levels-above-state-threshold

### March 1, 2021

County Environment Director research begins using "well log data" and current/historical information on the area.

## April 2021

NY State agrees to assist the County with a community sample program based on information collected including surrounding property uses, past and present. Sampling plan development begins to determine properties for samples, who collects them, where samples be sent, who pays for lab fees and overall cost.
