Canterbury Chase Homeowners Association October 16th, 2025 Meeting Minutes

- Meeting was called to order by HOA President Wayne Brockhum at 7:05PM
- 23 Homeowners were in attendance, including 3 current Board Members Wayne Brockhum, Jerry Shaw, and Scott Weber
- October 16th Meeting Minutes were read by Jerry Shaw and approved by members.

Committee Reports

- Treasurers report: President Wayne gave summary of our financial. Approved by Members.
- Secretary's report: Secretary Shaw noted that the updated Directories are ready for distribution. Discussion with membership regarding whether they should be distributed only to paid members or to all residents, was resolved in favor of having block captains distribute to all residents.

Old Business

- Canterbury Chase street signs are being refreshed with a new coat of primer and paint by members Linda Grzesik, Mary Ellen Banfield, and friends. Supplies have been provided.
- Mr. Shaw indicated that he is working on a flyer to solicit contractors for the proposed Neighbor Recommended Contractors web pages, which are to be added to the canterburychase.com website.
 The board is proposing to offer contractor listings of candidates recommended by two or more CCHOA residents for \$200/yr. Suggestions for a Web page title are still being taken.

New Business

- Membership was advised that the certified letter sent to Mr. Hahn, owner of the rental property on 67th avenue whose residents keep parking on the grass right of way, was returned undeliverable. Without having other contact information the violation will be referred to our Attorney, Mr. Zacur.
- Two other members, Justin Bastow at 11841 68th Ave, and Thomas Jerger of 11861 68th Ave., who had both recieved deed retriction letters in September regarding unauthorized structures on their property (deed restriction #5), asked the membership to consider granting them exceptions, similar to the one granted to the Swanks in October. It was agreed to give them an opportunity at the November meeting to make their formal requests, even though it is outside the time frame listed in the bylaws.
- The board, however, again made it clear that it does not have the ability to grant exceptions to the deed restrictions, only the membership has that power, and it was noted that very few exceptions have been granted in the past.
- Meeting was adjourned at 8:15 PM
