



# Troy Davis denied clemency by GA. Pardons Board

"I am Troy Davis!" was the battle cry echoed repeatedly on the steps of the Georgia Capitol building this past Thursday as hundreds of supporters gathered to rally for the life of a man accused of the murder of a Savannah police officer in 1989. Supporters, including members of the NAACP and Amnesty International, took to the podium to

protest the execution of death row inmate Troy Anthony Davis.

Passionate and angry voices took turns attacking, and sometimes, tearfully pleading to the Georgia Board of Parole and Pardons to grant freedom to Davis. Unfortunately, their cries fell on deaf ears. The Georgia pardons board denied clemency Friday, September 12, prompting the continuance of his scheduled execution date of September 23. All of his appeals are now exhausted and

his only hope for survival lies in the hands of George Bush or the United States Supreme Court, the last two executive authorities with the power to override his ill-fated sentence.

The wheels of justice have been flattened in the eyes of Davis' supporters, who are baffled that the State of Georgia is willing to kill a man in the absence of physical evidence and the recanted testimonies of seven out of the nine witnesses

It is working in Denver and now we are going to see if it can work in Atlanta.

"Donation meters" have come to help the fight against homelessness and to combat aggressive panhandling, which has plagued the downtown area for years.

These bright yellow meters with a blue sticker resemble parking meters, but they are designed to collect



your spare change, which will go directly to organizations that offer services for the homeless.

The meters are part of a threepronged approach to dealing with aggressive panhandling throughout the city of Atlanta and particularly in the Downtown Tourist Zone. The campaign is being spearheaded by Central Atlanta Progress, Atlanta Convention and Visitors Bureau, the Mayor's office, the Atlanta Police Department and other law enforce-

With the pageantry of the Democratic and Republican conventions behind them and Election Day less than two months away, presidential candidates Barack Obama and John McCain are ramping up their strategies for the final sprint to the White House. Already, McCain's first tactical move, the choice of Alaska Gov. Sarah Palin as his running mate, seems to have paid off-despite assessments that the decision was a cynical appeal to women still smarting from Democratic Sen. Hillary Clinton's loss in the primaries.

According to a recent compendium of national polls on Real-

since the primaries. That
lead, however, still falls

with the margin of error.
"People are excited about this ticket...this is a ticket that will govern Washington,"

said McCain campaign ad-

viser Rick Davis on "Fox News Sunday" last weekend.

According to an ABC News/ Washington Post poll released Sept. 8, Palin's biggest draw has been to White women who seem to identify with her "hockey mom" persona. Sixty-seven percent view her favorably — a figure that increases to 80 percent among White women with children at home — and 58 percent say her selection makes them more confident in McCain's decisionmaking, according to the poll. White women have moved from 50-42 percent in Obama's favor before the conventions to 53-41 percent for McCain now, a 20-point shift.

# Georgia senators navigate oil drilling fight

The last time Georgia Sens. Saxby Chambliss and Johnny Isakson tried to find middle ground in an emotional policy battle before Congress, they quickly abandoned a bipartisan immigration package after getting pilloried from the right.

Now the Republicans are in the thick of a debate over oil drilling, and they're again fending off criticism from the likes of Rush Limbaugh over a compromise that would raise taxes on oil companies while paving the way for new drilling off the nation's coasts.

The issue could come to a head this week as energy takes center stage on Capitol Hill and both parties maneuver to take credit for addressing \$4-a-gallon gas prices.

Chambliss and Isakson are so far standing firm behind their proposal, which started with backing from a so-called "Gang of 10" and now has 20 Senate sponsors. But as the package gains bipartisan support, it also is drawing complaints from Republicans that it undercuts GOP momentum on the year's most highprofile political issue weeks before the November elections.

Limbaugh has repeatedly ridiculed the proposal on his conservative radio show, saying House Republicans are pressing for much more ambitious drilling while the Senate proposal "basically cuts (them) off at the knees."

The senators also have taken heat from congressional colleagues, including from fellow Georgia Republicans. Rep. Phil Gingrey of Marietta has said the senators are engaged in "procedural pleasantries" while Rep. Tom Price of Roswell contended their approach "doesn't make any sense to me.'

Price said it is "foolhardy" to leave vast coastal areas off limits to drilling and said "tax increases on domestic oil production is counterproductive to bringing new American energy to the market."

Chambliss and Isakson dismiss the criticism, arguing that voters want Congress to set aside differences and agree on something that will make a difference - even if it requires trade-offs.

"Usually if the extremes are raising cain, it means you're doing something right," said Chambliss, who spearheaded the compromise along with Sen. Kent Conrad. a North Dakota Democrat. "We think if anything is going to get 60 votes, it's going to be our proposal."

The plan would allow drilling 50 miles off the coasts of Virginia. South Carolina, North Carolina and Georgia, and the Gulf coast of Florida. It would eliminate tax breaks for the oil and gas industry to generate some \$30 billion in revenue, with the money used to offset a massive new investment in alternative en-

Republicans such as Gingrey and Price want an "all of the above" bill that would allow far more new drilling all along the East and West coasts and in restricted areas of Alaska, without the tax increases on domestic producers.

In years past, any new offshore production would have spawned a firestorm of criticism from drilling critics who argue that it could cause irreversible environmental harm and only a marginal impact on global oil prices. But with voters outraged about the price of gas, the critics appear resigned to allowing some new exploration.

Democratic House Speaker Nancy Pelosi has outlined a package that is more in line with the Senate compromise than with Republican



Last year, Chambliss and Isakson acknowledged that they backed out of the bipartisan coalition on immigration in part because of a strong backlash from conservative constituents.

While there have been calls of protest on their drilling plan, they say they haven't heard anywhere near the level of concern that they had on immigration and that they won't give up on their "gang" unless the package gets altered.

'As long as nobody tries to shift the policies in the proposal, we're not going to do that," Isakson said. "We've got a solid group."

# Ga. revenues continue to slide, more cuts possible

Georgia's economy continues to sputter. Gov. Sonny Perdue reported that state revenues tumbled again in August, down 7 per-



cent from the same month the vear be-For fore. the fiscal that year started July 1, tax collections plummeted 6.8 percent or more than \$180 million.

The financial snapshot released was bleak.

All major revenue streams were down sharply in Georgia including sales, income and corporate taxes

Georgians were buying less food, clothing, furniture and automobiles, the state data showed.

'You are looking for a light at any point and so far we haven't seen that light," Perdue

The Republican governor has already ordered state agencies to trim spending by 6 percent to close a projected \$1.6 billion budget gap this year. Agencies have also been told to draw up plans for even steeper cuts and Perdue said unless the flow of money into state coffers picks up those additional cuts could be

The state plucked \$600 million from its reserves to stay in the black for the previous fiscal year as Georgia's economy began to sour.

Perdue said he has no immediate plans to release \$428 million in homeowner tax relief grants, despite complaints that his failure to do so could lead to higher property taxes. The grants are distributed to local governments and designed to keep property taxes down. Local governments have already passed that tax savings along to homeowners. State lawmakers have pledged to restore the funds to keep local governments from being forced to boost property taxes to make up the shortfall in state funds.

But Perdue argued that, at least for now, the money isn't there.

"It would be imprudent for me at this point in time to say everything is fine based on August numbers and that we will all live happily ever after," Perdue told reporters at the state

The revenue numbers come a day after the state reported a jump in first-time jobless claims rivaling those that came in the aftermath of the terrorist attacks of Sept. 11, 2001. There were 50.090 first-time unemployment claims in August, an increase of 72 percent from August of 2007

State money managers reported Friday that income tax collection are off by 6.5 percent for the first two months of the fiscal year. Sales tax revenues have dropped 8.5 percent. And corporate income tax has fallen by more than 33 percent.

Motor fuel taxes, which fund road and transportation projects, have dipped 7 percent. State Revenue Commissioner Bart Graham said that appears to be a result of Georgians buying less gas, presumably because they are driving less.

One bright spot on the state's balance sheet: booze sales appear to be up. Revenues from the state tax on alcoholic beverages which retailers pay the on the stock they buy from wholesalers – ticked up 1.8 percent.

New Report Finds AIDS Spreading Among Young Black

A new report which has been described as "unusually detailed" finds that the hardest hit population is actually young Black gay and bisexual than whites and 2.3 times more likely that Hispanics to have the virus which causes AIDS.

The CDC report also was its most specified new HIV/AIDS infections for the first time in terms of race, gender and age. It was based on 2006 data - the latest year for which full figures are available. However, Black females are by no



males between the ages of 13 and 29. They are followed by white gay men in their 30s and 40s, Hispanic gay men and Black women.

In fact, the September 12th Morbidity and Mortality Weekly Report from the Centers for Disease Control and Prevention (CDC) labeled the incidence of HIV infection among Black males 13 to 29 as "alarming." They were 1.6 times more likely

means out of the woods. They have an infection rate 14.7 times that of white women.

There is some speculation among experts that the "alarming" HIV infection rate among Black males aged 13 to 29 may result in part from the large number of young Black males being incarcerated. But no firm data has yet been presented to confirm that theory.

## Countries Throughout the World Favor Obama for U.S. **President**

They may not be able to vote in a U.S. election but if the citizens of the world had their way Democratic candidate Barack Obama would be the next president of the United States by an overwhelming margin. The margin in favor of Obama ranges from 9 percent in India to 82 percent in Kenya. The most common view (17 out of the 22 countries) was that if Obama is elected president. U.S. relations would greatly improve with the rest of the world.

Despite the preference for Obama, significant proportions of



All 22 countries in a poll conducted by the British Broadcasting Company (BBC) favored Obama over Republican John McCain.

Overall, 49 percent of the 22,000 people polled favored Obama while just 12 percent preferred McCain.

the populations in several countries did not favor either candidate. For example, 75 percent of those polled in Russia did not like either Obama or McCain. The BBC poll results were released last week.

# No Blacks Seated on O.J. **Simpson Jury**

The jury was seated in the armed robbery and kidnapping trial of former football great O.J. Simpson in Las Vegas. It is composed of nine women and three men - none of them African American. Simpson lawyers complained of bias charging that Blacks were "systematically" excluded after prosecutors removed the only Black person who was in contention to be on the jury.

Many legal experts believe an all white jury greatly increases the likelihood that the 61-year-old Simpson will be convicted for allegedly robbing in a Las Vegas hotel last year

Simpson was acquitted in Los Angeles in 1995 of murdering his ex-wife Nicole and her friend Ronald Goldman. Instead of the brilliant legal work of the late Johnny Cochran, many observers felt Simpson was largely acquitted because the iury was composed mostly of Black women. In the current case, there were reports that prosecutors had planned to do whatever was legally possible to prevent Blacks, especially Black women, from being on the Las Vegas jury.

## World Renowned Muslim Leader Imam W.D. Mohammed Dies at 74

Imam W.D. Mohammed, one of the nation's most prominent orthodox Black Muslim leaders, died last week at his Chicago home. He was 74. Mohammed's father, Elijah Muhammad, founded the black nationalist Nation of Islam. But in 1976, after his father's death in 1975, Mohammed dropped some of the more militant and separatist aspects of his father's teachings and move toward orthodox Islam.

However, this move led to a conflict with one of the religious sect's most prominent figures - the often controversial Minister Louis Farrakhan. The con-

flict produced a split in the organization with some members following Mohammed and others joining Far-

In 1981, Farrakhan reclaimed the name "Nation of Islam." By 1983



Mohammed and Farrakhan had reconciled but each continued with different interpretations of Islam.



This begs investigation and it looks like we are going to have to rely once again on the National Enquirer or another rag like that. Âmerica deserves the truth because our future depends on it. What has happened investigative journalism?

involved in Mr. Davis' prosecution.

Doubt is at the center of this capital case as witnesses have come forth and declared in sworn affidavits that many of them were coerced and manipulated by the police in order to secure the conviction of Troy Davis

Antoine Williams, who was working at the Burger King at the time that the officer was murdered, stated that police gave him statements to sign that implicated Troy Davis as the murderer. He also states that he signed the statements without reading them because he was illiterate. Williams went on further to say that he felt pressured to identify Davis as the killer and that he was always unsure of who the actual shooter was.

Dorothy Ferrell was another witness claiming to be victimized by police intimidation and coercion. She had just been recently released from prison at the time of the crime, and was staying at a hotel near the fatal scene. She stated that she feared that the police would put her back in prison if she didn't cooperate so she identified Davis – even though she had no idea who the shooter was.

Sylvester "Red" Coles was one of the two witnesses that did not change his testimony, but may not have because of his own involvement in the crime. He is a main

suspect in the murder, as far as Troy Davis' defense team is concerned.

Witnesses have come forward and told the defense that it was he, not Troy, killed the officer. Tonya Johnson stated in a 1996 affidavit that she had known Coles all of her life and was "scared to death" of him. She said he had threatened to kill her after she wouldn't hide guns for him on the night of the murder. Johnson only kept quiet because she feared for her safety, but decided that she had no choice but to tell the truth.

These post trial revelations seemed like enough to free Troy Davis from the confines of prison, but were only enough to earn him a 90-day stay of execution just 24 hours before he was scheduled to be put to death last year. Troy Davis' lawyers immediately attempted to get a new trial for their client in light of the witness recants and possible misconduct by Georgia police, but their requests were denied and dismissed as hearsay.


Clayton County NAACP president, Dexter Matthews, blames the state's backward thinking as the reason that new testimony and essential evidence has been ignored in this capital murder case. "A lot of these folks think right is wrong, and wrong is right...I'm not even going to try to rationalize why they do it.

It's just backwards and barbaric."

ACLU lawyer John Holdridge reasons that the overall death penalty system is out of control and fraught with error. "The judicial system," he expressed poignantly, "has become like an eighteen wheeler barreling down a mountain without any run-off lanes to stop it...the system is incapable of correcting its own mistake."

Amnesty International regional director Jared Feuer is shocked that the board did not commute the death sentence and has vowed to fight until the end. "This case has everything that is wrong with the Death penalty – you have racial bias, you have tampering with witnesses, you have procedural limitations getting in the way of justice... inadequate access to legal council, it all comes together in Troy Davis' case...this is a heartbreaking case."

While the rest of the country mourned and commemorated the incomprehensible tragedy of the loss of lives which took place on the same date seven years earlier, family, friends, and supporters of justice, freedom, and Troy Davis fought the good fight to save not only the life of one man, but the life and fairness of the justice system that is in place to protect and serve us all.

ment agencies and the private sec-

"The role of this comprehensive program is to educate and convince employees and residents, students and visitors that giving money to panhandlers is not an authentic charity and rather we are encouraging them to do otherwise," said Mayor Shirley Franklin at a City Hall news conference. "Also to make panhandlers aware that their actions are against the law in the city of Atlanta."

The meters will be placed in areas that have high foot traffic throughout out downtown. The first five will be placed by Friday (Sept. 19), at City Hall, the Gateway Center on Pryor St. the Georgia World Congress Center, Atlanta Police Zone 5 Precinct at Spring Street and International Boulevard and the Atlanta Hilton Hotel.

The goal is to have them placed in front of all of the downtown hotels and other high foot traffic areas, said Councilmember Debi Starnes.

Mayor Franklin, along with other members of the public safety taskforce, recently visited Denver on a fact-finding trip to see how their donation meter program has been working in their fight against homelessness and aggressive panhandling. They based Atlanta's *Give Change That Makes Sense* campaign on the Mile High City's program.

The partners in the program wants the public to know that their research has found that most of the aggressive panhandling has come not from the homeless but from "hustlers" who are for the most part not homeless, Starnes said.

"We also want people to understand the difference between homeless people and hustlers. There is an overlap between the two groups, but largely they are two separate populations," she said. "So the people who are aggressively panhandling, who are hurting people and going after people are not typically homeless persons and we want the public to understand that. So giving money to those persons you are not only not helping the homeless, most often you are giving money to criminals."

Although there has been a solicitation law in effect for the past three years, complaints about aggressive panhandling from tourists, business visitors and downtown residents and employees have continued to increase.

"Incidents of aggressive panhandling has not only been damaging to the visitor's Atlanta experience but also damaging to our reputation Atlanta as a top destination," said Kathleen Bertrand, vice president of ACVB. "Seasoned travelers have told us that the level of panhandling that they experience in Atlanta is unlike that of any major city where they do business."

An informal survey of visitors in

the lobby of hotels found that panhandling was the number one reason visitors said they would not return to the city, Bertrand added.

Conventions have an \$11.4 billion economic impact on the city of Atlanta.

In August, the Atlanta Police Department instituted an undercover operation where police officers were disguised as tourists or conventioneers to address aggressive panhandlers, said Police Chief Richard Pennington.

During that time 50 arrests were made and 50 interventions were made where no arrests were warranted. Of those 50 arrests, no one was arrested twice, he said.

"This initiative educates the

community and provides assistance to organizations serving those in need and provides immediate enforcement from police agencies if an incident warrants police intervention," Pennington said.

The effectiveness of the program will be evaluated after six months, Franklin said.

The *Give Change That Makes Sense* campaign will have referral cards and posters and other support material that people and businesses can download.

It has been difficult for a television show centered around family values and community empowerment to remain afloat in a sea of never-ending reality shows and primetime soap operas-nearly impossible for a show with a primarily African-American cast to even tread water among such sharks. But, the ABC Family Channel dramatic series, Lincoln Heights is making a splash as it goes into its third season this fall.

Lincoln Heights is about Eddie Sutton, a police officer who moves his wife and three children from Chicago back to his old neighborhood in Los Angeles, California in an effort to give back to the place where he grew up. Executive Producer and head writer, Kathleen McGhee-Anderson finds the show entering its third season, "gratifying. It's very difficult to get a show to the third season. You define the show in the first season, that's the biggest hurdle... you have to find an audience and make sure that audience holds through the second season. And when you get to the third season, it feels like you've done it right. The audience connects, the network is validating you and you really hit a groove in the third season," she

Historically, there have only been a few successful Black dramatic series on the major networks. Currently, there is no other dramatic series on television that has an African-American cast as its central characters. There are several shows that have African-American characters that add color and diversity to a bigger picture. Some would say the problem is that there is not enough backing by the networks. These days, that is becoming less true. The bigger issue lies in having an experienced staff that can relate to African-American audiences and tell their stories, not from a secondhand observation but from a more personal point of view-meaning more Black producers, writers, and directors

McGhee-Anderson said. "There have been attempts to have African-American family dramas on television. James Earl Jones had one years ago. None have really succeeded beyond a season. There was a hospital series that Steven Bochco put on the air maybe five years ago but those stories were not told by an African-American executive producer/showrunner. And as the executive producer/show-runner. I'm the head writer. So, stories that really ring true and have authenticity about a community... Those stories are authentically told when you have someone who comes out of that experience. It's not pretending to capture what the African American experience is. This is the real deal!'

Most of the successful shows for Black audiences on television have had more of a comedic theme. Not to take away from the impact that The Cosby Show, The Fresh Prince of Bel Air or even Good Times had on portraying a positive image of Black families in mainstream media, but McGhee-Anderson was candid in saying that, "The basis of sitcoms is that it's a situation that is manufactured—it's a 'situational comedy'. Generally they are based on situations that you can get jokes from. It's somehow associated with... If you show Black folks laughing... It's the old tradition of African Americans being accepted as long as they can shuck and jive and laugh and dance."

No television show's success is solely based upon whether or not the actors or central characters are of a particular race or background. Lincoln Heights is no different. With the premise set in a diverse community, this show has been praised because it appeals to the real lives of people across many demographics. It speaks to universal ideas of family, love, civic responsibility, race relations, politics, and respectissues that every family in America can relate to.


Nicki Micheaux plays the role of Jen Sutton, Eddie's wife, and a nurse and the mother of their three children. She feels the cast's characters are real people with real issues and that "most of the things this family deals with are not specific to Black Americans. The things this family struggles with are very common family dynamics. The center of the show is love and hope and it's the heartbeat of the show that gets us through those things that happen in life.

Leading African-American ladies in Hollywood have been noticeably lighter in complexion as opposed to Micheaux's darker skin tone. McGhee-Anderson explained that although the issue of skin tone has been one to deal with in the past, while it's not a non-issue today, it's not as much of a hurdle as it was before. She said, "Color has nothing to do with talent. It is truly limiting, and it has been for our race when we impose it on ourselves... It really

handicaps our power when we let the color issue stand in the way of what is described as the best representation of who we are.'


As far as having more African Americans running the show, McGhee-Anderson said, "Hollywood just has to now step up and welcome the African-American writer show-runners and give them a vote of confidence and understand that they have the ability and the talent to run a show and deliver a product that will be relatable to a broad audience which they have to appeal to. At the bottom line, we are talking about a business. This is a business at the end of the day. It's just not here to entertain. It's here to sell product... With the new regime of younger executives coming into Hollywood... [They] don't see those barriers between us that older generations have enforced in this town. The future is bright because this new regime will be more open to recognizing talent no matter what the color is.'







# Young African-American males face mental health crisis

A significant increase in mental illness and behavioral problems among adolescent African- American males demonstrates the need for new approaches to treatment and better understanding of the complex challenges facing these youths, according to a policy paper issued by Community Voices: Healthcare for the Underserved, an advocacy group based at Morehouse School of Medicine.



The paper, titled "The Secret Epidemic: Exploring the Mental Health Crisis Affecting Adolescent African-American Males," outlines data indicating that mental health problems are rising among members of this at-risk group, their access to treatment facilities is relatively low and treatment strategies must be revamped to address the socioeconomic issues that confront them.

"Our research found that many young Black males are treatable, but they are going undiagnosed because of failures in America's health-care system," said Dr. Henrie M. Treadwell, Director of Community Voices, a nonprofit seeking to improve health services and access to health care. "Our entire society feels the impact of this failure. Suicides and homicides have increased for this group, and the residual effect is impacting communities across the country. This problem must be addressed.

Dr. Claire Xanthos, a health services research specialist, wrote the paper, which cites studies showing that black males ages 15-19 die from homicide at 46 times the rate of their white counterparts and that from 1980 to 1995, the suicide rate for black adolescents rose from 5.6 to 13 per 100,000 of the population.

Xanthos writes that "these figures should not be surprising since adolescent African-American males in contemporary American society face major challenges to their psychological development and wellbeing. In addition to dealing with the physical, mental and emotional issues typically experienced during adolescence, adolescent African-American males are confronted with unique social and environmental stressors. They must frequently cope with racism and its associated stressors, including family stressors,

educational stressors, and urban stressors 3

Moreover, the paper notes that:

Racism can affect mental health

by reducing socioeconomic status, diminishing access to desirable resources and contributing to poor living conditions.

When positive adult male role models are absent, many Black youths turn to their peers for help in forming a male identity, an adaptation that often means absorbing negative influences

Urban stress is an important factor in the psychological development of young black males because many live in deprived and dangerous neighborhoods where they are exposed to violence

Significant problems are also encountered by Black males who grow up in predominantly white middle-class communities where they feel distanced from the white youths and also from Blacks from poorer communities.

Citing these problems, the paper makes a plea for better access to mental health treatment for young black males, noting that they currently often confront a "confusing maze" when trying to get help.

The paper notes that when young Black youths do find treatment, depression is often overlooked because their symptoms often differ from white youths.' For cultural and social reasons Black youths often express suicidal feelings through somatic complaints rather than sadness or depres-

Moreover, the paper calls for more "bicultural" training for young Black Such training would better prepare them to follow proper behavior in school and the workplace, while also working with young Black males to get them ready to deal with the discrimination they are likely to face. Also cited is the need for a significant increase in the number of Black therapists available to work with African-American youths.

Dr. Treadwell said it is essential that new policies be implemented to address the social and environmental factors that create poor mental health outcomes for young Black males

"We must increase the capacity of America's mental health system to help resolve the problems faced by young Black males," she said. "There must be more research in this area, and more people of color must be trained and hired to help

this at-risk group."





No advertisement can provide all the information needed to determine if a drug is right for you or take the place of careful discussions with your health care professional. Only your health care professional has the training to weigh the risks and benefits of a prescription drug.

# WHAT IS THE MOST IMPORTANT **INFORMATION I SHOULD KNOW ABOUT SYMBICORT?**

- In patients with asthma, long-acting beta,-agonist (LABA) medicines, such as formoterol (one of the medicines in SYMBICORT), may increase the chance of death from asthma problems. In a large asthma study, more patients who used another LABA medicine died from asthma problems, compared with patients who did not use that LABA medicine. Talk with your health care professional about this risk and the benefits of treating vour asthma with SYMBICORT.
- SYMBICORT does not relieve sudden symptoms, so you should always have a fast-acting inhaler (short-acting beta,-agonist medicine) with you. If you do not have this type of inhaler, talk with your health care professional to have one prescribed for you.
- Get emergency medical care if your breathing problems worsen quickly and your fast-acting inhaler does not relieve them.
- Do not stop using SYMBICORT unless your health care professional tells you to stop because your symptoms might get worse.

# WHAT IS SYMBICORT?

SYMBICORT is an inhaled prescription medicine for long-term maintenance treatment, taken twice a day, every day, to control asthma in patients 12 years and older. It will not replace your fast-acting inhaler for relief of sudden asthma symptoms

SYMBICORT contains two medicines:

- Budesonide (the same medicine found in PULMICORT TURBUHALER® [budesonide inhalation powder], PULMICORT FLEXHALER™ [budesonide inhalation powderl), an inhaled corticosteroid medicine, or ICS, ICS medicines help to decrease inflammation in the lungs. Inflammation in the lungs can lead to asthma symptoms.
- Formoterol (the same medicine found in Foradil® Aerolizer®) is a long-acting beta2-agonist medicine, or LABA. LABA medicines help the muscles in the airways of the lungs stay relaxed to prevent asthma symptoms, such as wheezing and shortness of breath. These symptoms can happen when the muscles in the airways tighten, which, in severe cases, can cause breathing to stop completely if not treated right away.

# WHO SHOULD NOT TAKE SYMBICORT?

You should NOT take SYMBICORT if your health care professional:

- decides that your asthma is well controlled using another asthma-controller medicine
- you only use a fast-acting inhaler less than twice a week

# WHAT SHOULD I TELL MY HEALTH **CARE PROFESSIONAL BEFORE USING SYMBICORT?**

Tell your health care professional about all of your health conditions, including if you

- have heart problems
- have high blood pressure
- have seizures
- have thyroid problems
- have diabetes
- have liver problems
- have been on an oral steroid, like prednisone
- have osteoporosis
- have an immune system problem or have been exposed to chicken pox or measles
- have tuberculosis or other infections
- are pregnant or planning to become pregnant because it is not known if SYMBICORT may harm your unborn baby
- are breast-feeding because it is not known if SYMBICORT passes into your milk and if it can harm your baby

Tell your health care professional about ALL the medicines you are taking, including all your prescription and nonprescription medicines, vitamins, and herbal supplements.

SYMBICORT and certain other medicines may interact with each other and can cause serious side effects. So be sure to keep track of ALL the medication you take. You might want to make a list and show it to your health care professional, including your pharmacist, each time you get any new medicine, just to ensure there are no potential drug interactions.

# **HOW DO I USE SYMBICORT?**

Do not use SYMBICORT unless your health care professional has carefully demonstrated how to do so. If you have any questions concerning the use of SYMBICORT, ask your health

SYMBICORT should be taken twice every day as prescribed by your health care professional.

SYMBICORT comes in two strengths. Your health care professional will prescribe the strength that is best for you.

## When you use SYMBICORT, make sure you

- use SYMBICORT exactly as prescribed
- take two puffs of SYMBICORT in the morning and two puffs in the evening every day. If you miss a dose of SYMBICORT, you should take your next dose at the same time you normally do
- do not take SYMBICORT more often or use more puffs than you have been prescribed
- rinse your mouth with water after each dose (two puffs) of SYMBICORT without swallowing
- do not change or stop any of the medicines you use to control or treat your breathing problems. Your health care professional will adjust your medicines as needed
- always have a fast-acting inhaler with you. Use it if you have breathing problems between doses of SYMBICORT

## Seek emergency medical care if

- your breathing problems worsen quickly and your fastacting inhaler does not relieve your breathing problems
- vou experience any symptoms of a serious allergic reaction to SYMBICORT, such as a rash; hives; swelling of the face, mouth, tongue; and breathing problems

## Contact your health care professional if

- you need to use your fast-acting inhaler more often
- your fast-acting inhaler does not work as well for you at relieving symptoms
- you need to use four or more inhalations of your fast-acting inhaler for 2 or more days in a row
- you use up your entire fast-acting inhaler canister within 8 weeks
- your peak-flow meter results decrease. Your health care professional will tell you the numbers that are right for you
- your asthma symptoms do not improve after using SYMBICORT regularly for 1 week

# WHAT MEDICATIONS SHOULD I NOT TAKE WHEN USING SYMBICORT?

While you are using SYMBICORT, do NOT use other medicines that contain a long-acting beta,-agonist (LABA) for any reason, such as

- Serevent® Diskus® (salmeterol xinafoate inhalation powder)
- Advair Diskus® or Advair® HFA (fluticasone propionate and salmeterol)
- Foradil® Aerolizer® (formoterol fumarate inhalation powder)

# WHAT ARE OTHER IMPORTANT SAFETY **CONSIDERATIONS WITH SYMBICORT?**

- Cardiovascular and central nervous system effects of LABAs, such as chest pain, increased blood pressure, fast or irregular heartbeat, tremor, or nervousness
- Immune system effects and a higher chance for infections
- Osteoporosis. People at risk for increased bone loss may have a greater risk with SYMBICORT
- Slowed growth in children. As a result, growth should be carefully monitored
- Eye problems, such as glaucoma and cataracts. Regular eve exams should be considered while using SYMBICORT

# WHAT ARE OTHER POSSIBLE SIDE **EFFECTS WITH SYMBICORT?**

- Nose and throat irritation
- Headache
- Upper respiratory tract infection Sore throat
- Sinusitis
- Stomach discomfort

# Free Health Expo available for women and families

On Nov. 14-15, the Center for Black Women's Wellness, Inc. (CBWW) will host its 20th Anniversary Celebration, including an Awards Ceremony and Women's Health Expo at the Twelve Hotel in Atlanta's Atlantic Station.

Serving as Atlanta's only organization committed to addressing all of the key factors impacting the poor health and wellness of Black women, CBWW has impacted the lives of more than 10.000 metro Atlanta women and families through its core health and wellness services over the last two decades. Proceeds from CBWW's 20th Anniversary Celebration benefit the organization's longstanding efforts to improve and empower the holistic wellness of Atlanta's black and uninsured women

The Awards Ceremony kicks off this two-day celebration, featuring a keynote address by Byllye Y. Averv. founder of the National Black Women's Health Project (now the Black Women's Health Imperative), the organization by which CBWW was initially established. As a women's health activist for more than 30 years, Avery has helped turn the issue of Black women's health into a movement, advocating for healthcare reforms and emphasizing prevention and primary care. Avery is also the president and founder of the Avery Institute for Social Change.

Other ceremonial highlights include a musical performance by Shades of Pink, the first ever survivor's choir made up solely of breast cancer survivors; and six award presentations to health practitioners, advocates and organizations dedicated to the improvement

of women's and minority healthcare in Atlanta.

Awards sponsor, InnerCity Medicine Networks, will produce video vignettes that spotlight awards recipients in the environments where they make the most difference in lives of women and underserved populations. WSB-TV news anchor and recent breast cancer survivor-JaQuitta Williams— will serve as the event's Mistress of Ceremonies.

"The Center for Black Women's Wellness is a place where all women can gain access to proper healthcare, regardless of socioeconomic status,' says Jemea Dorsey, CBWW's Chief Executive Officer. "This mission

# Where a Woman Lives May Affect Her Risk for Preterm Birth, Study Finds

Unique characteristics that distinguish one city from another -such as region, size and local economy -- may impact preterm birth rates among U.S. women, according to a study in the September-October 2008 issue of Public Health Reports.

These city characteristics may also help to explain some of the long-observed, but poorly understood racial disparities that contribute to a higher preterm birth rate among Black women in the U.S., says lead study author Michael Kramer, MS, MMSc, an epidemiology researcher at the Rollins School of Public Health, Emory University.

Kramer and team examined

the impact of city size, region of the country, and differences in the economic and educational characteristics of 168 U.S. metropolitan cities on the very preterm (VPT) birth rate among white, Black and Hispanic women. Very preterm birth is a birth that occurs before 32 weeks gestation. A full-term birth occurs at or after 37 weeks.

The study found that the cityto-city variation of very preterm births was higher among Black women than white women. In each of the cities, Black women experienced 2-3 times greater risk for very preterm birth than white women, Kramer says. The difference between highest- and lowest-risk cities for Blacks was three times the difference between highestand lowest-risk cities for whites.

'While it is well reported that there is an overall racial disparity in very preterm birth, this study is one of the first to look at the impact that cities may have on preterm births," says Kramer. "The size of the racial gap between Black women and white women changed from one city to another, and suggests that there may be something about the actual places where these women live that could be intervened upon to lower women's risk for preterm birth."

The seven Georgia metropoli-

tan areas included in the analysis mirrored the overall analysis with Black women at higher risk for very preterm birth. The risk for VPT birth for white women varied from a low of 0.8 percent in Athens, Ga. to the highest at 1.4 percent in Macon, Ga., while the risk for Black women varied from a low of 2.7 percent in Atlanta to the highest at 4.3 percent in Athens, Ga.

Very preterm birth is the leading cause of U.S. infant mortality and one of the strongest risk factors for pediatric disabilities such as cerebral palsy. Decades of research have identified a handful of preterm birth risk factors, but none of which

explains the increased risk experienced by U.S.-born Black women.

"We already know that public health efforts to reduce racial disparities in pregnancy outcomes must target individual needs," says Kramer. "Now we must also consider characteristics of the places women live if we are to eliminate racial disparities associated with preterm birth."
