In response to your request extending a formal invitation to bid on HVAC service and equipment replacement for the Green Valley Villas West Community as per your request for price, we are privileged to provide our formal proposal specifically by replying to each item identified in the scope of work in sequential order for your inspection and analysis as you requested directly below with our pricing and the terms:

HVAC Replacement: We propose to furnish all materials and perform all labor as necessary to complete the following:

ITEM A

- 2.5 ton Day & Night model # IPGD430040KTP1E Gas Pack, 14.0 seer, 11 eer Price Per Unit Installed Complete = \$4,880

ITEM B

Electrical - High Voltage

- Turn the power off at circuit breaker for each piece of equipment at the main panel.
- On roof, test for voltage. It should be off. Loosen all screws inside of the existing disconnect for each wire connection including ground.
- Remove load side (bottom) wiring and conduit/flex from the existing disconnect completely.
- Remove old disconnect, replace with new disconnect. Re-connect line side (top) wiring.
- Install new UV resistant CAR flex with metal connectors from dis-connect to HVAC unit.

- Conduit must be added if over six ft. (6') in length from dis-connect to the HVAC unit (PER CODE); metal connectors used.
- EMT clamps are placed within 12" of each of the electrical connections and then every eight (8') feet in between.
- 4" x 4" x 6" redwood blocks will be used to keep connect off roof surface.

Electrical – Low Voltage

- If no covering had previously been used on existing thermostat wiring, we will set new ½" flashing on the roof. We will three course seal the new flashing; roof cement (tar) under the flashing; nailed to the roof; tar over the nails; then add a mesh membrane and then *Kool Koat*™ white to complete.
- If the existing thermostat wire has not sun rotted, we will install CAR flex from flashing to the HVAC unit. If the wire is found to be rotted, we will connect new 2" x 4" rain-tite box with a blank cover to the flashing so wiring can be safely spliced.
- We will then run new thermostat wire from the rain-tite box to the HVAC unit using CAR flex and metal connectors. Note: if this connection is in excess of 6' in length, conduit will be used.
- EMT clamps are placed 12" from both end and then every eight (8') feet in between.
- 4" x 4" x 6" redwood blocks will be used to keep connect off roof surface.

Roof Duct

- We will mastic seal ALL joints in new duct.
- We will use roof cement (tar) for connection of duct work to roof.
- We will fabricate and furnish legs to support new duct work if duct work is longer than three (3') feet.
- Duct support legs shall be "L" shaped with a 3" square for each leg.
- We will Kool Koat™ all roof duct (top and both sides) to provide heat rejection.

Gas Piping

- We will turn gas off at the main and dis-connect gas line from the existing unit.
- We will remove the existing gas flex and existing valve and discard.
- We will re-use the existing gas line. If additional length is required, we will provide same diameter size gas piping and use pipe joint compound for every pipe connection.
- We will install new the new gas valve; "" valve less than 60,000 BTU's or "" valve if greater than 60,000 BTU's.
- We will install gas flex line not to exceed 18" in length.
- We will add sediment trap at HVAC unit and install clean-out pipe to be at least 3" in length and capped.
- We will furnish 4" x 4" x 6" redwood blocks to support the gas line with EMT clamps and keep off the roof surface.

Condensate Drain

- We will use ¾"Ø PVC piping for all units.
- We will install one PVC union at the HVAC unit fitting allowing for ease of dis-connect for cleaning of condensate line.
- We will either fabricate on-site a P-trap using 90° elbows, or we will provide a pre-fab P-trap and install a T connection on the down-hill side of the trap for proper venting (PER CODE).
- We will run condensate pipe to the existing termination or to the existing roof drain.
- If roof conditions require condensate to be run to an existing downspout, downspout must drain directly to dirt. Downspout cannot drain to as asphalt or concrete (PER CODE).
- We will furnish 4" x 4" x 6" redwood blocks to keep off the roof surface and to support condensate piping every six feet (6') (PER CODE) with 3/4 EMT clamps.
- We will coat drain line for UV protection to prevent sagging and thus sustaining its rigidity.

ITEM C

• Thermostat to be provided on each replacement unit will be Emerson Blue Easy Ready Thermostat # 1F95EZ Per Residential Code, all thermostats must have programable capabilities.

ITEM D

We will conduct final inspections at completion of installation for all unit replacements.

ITEM E

- We will sub-contract with a crane service for old unit disposal and for lifting the new unit onto rooftop for each replacement.
- We will remove and properly salvage and recycle existing rooftop unit (Metal, Copper, Aluminum, and Refrigerant all to be recycled).

ITEM F

■ We will furnish 4" x 4" x 6" redwood blocks as specifically detailed above.

ITEM G

• We will provide the permits for each and every unit replacement and we confirm that all permit costs are included in the unit price as quoted in Items A & B above.

ITEM H

WARRANTY based on residential purchase: FIVE (5) years on all OEM manufactured parts / ONE year labor.
 HAMSTRA WILL REGISTER THE HOMEOWNER (ON-LINE) to obtain TEN (10) year warranty on all OEM manufactured parts / ONE year Hamstra labor (Hamstra warranty).
