Delhi: Patiala court Advocate **Vishnu Joshi** says, "Earlier, an anticipatory bail application was filed in the Rohini Court in Delhi, which we had opposed. If they file any bail application or any other plea today as well, we will strongly oppose it. We want transit remand to be granted so that they are taken to Goa, where the due legal process can be followed."

Delhi: Patiala court Advocate **Vishnu Joshi** says, "Basically, the incident occurred on the night of the 6th–7th in Goa, in which a total of 25 people lost their lives. The most tragic aspect was that four members from the same family died. Out of the 25 victims, 20 were club employees, and five were tourists. Among these tourists, one was from outside Delhi, while the four from Delhi who died were all from the same family. We are representing these four victims on behalf of the family, including the wife, who survived, while her husband and three sisters passed away in the incident."

Delhi: Patiala court Advocate **Vishnu Joshi** says, "As of now, the investigation is at a very crucial initial phase. First, they will be taken from here to Goa on transit remand and produced before a Goa court, where their police remand will be sought. After the remand period, they may again get opportunities to file for bail, either even today or at a later stage. Whenever they file a bail application, we will oppose it 100 per cent. Even after the charge sheet is filed, we will go to Goa and face the entire trial, opposing their bail at every step, so that the Goa Police can secure their transit remand and proceed with the investigation properly."

Delhi: Advocate **Vishnu Joshi** (Victim's lawyer) says, "The formal arrest of the Luthra brothers by Goa Police at the airport today, after bringing them from abroad, has been completed. They underwent a medical examination, and a transit remand application was filed in court. The application sought a 3-day transit remand, but it was informed that they will be taken directly to Goa. Consequently, a 2-day transit remand has been granted..."



Delhi: Advocate **Vishnu Joshi** (Victim's lawyer) says, "On December 6th and 7th, a fire broke out in a club in Goa, claiming the lives of 25 people. The deceased were mostly employees of the club, while five were tourists, including one foreign national. Four victims belonged to the same family in Delhi. During the investigation, it was revealed that the club owners, Gaurav Luthra and Saurav Luthra, had fled to Thailand to evade the inquiry. They also filed an anticipatory bail application in Rohini Court while in Thailand, which was subsequently rejected. Following a coordinated operation by Central Agencies, they were brought back to Delhi, where Goa Police formally arrested them..."
