In 2023, Boxes of Basics were distributed to over 1450 local children in Prince William County, Manassas and Manassas Park and delivered to over 70 local schools and organizations. More than 40 local businesses and organizations partnered with Boxes of Basics to host donation drives, and in excess of 300 volunteers were engage to help sort clothing and pack boxes. In order to meet the demand of the communities we serve, in August 2023, the Boxes of Basics headquarters relocated from a small, donated space to a large, rented warehouse space located at 9239 Mike Garcia Drive in Manassas. The move was necessary to help us meet the growing demand for our services. Moreover, the move underscores our ongoing commitment to the families of Prince William County children who face clothing insecurity.
