Artwork: Artists are encouraged to bring their best work. Well-done pigment archival prints are acceptable. Works on paper should be framed and protected. Work must be ready for display and wired for hanging. There should be no raw edged canvas, staples showing, or saw-toothed hangers. Works should be at least 6 inches or longer on their shortest side.

Shows will rotate approximately every three months. No nudes at this location.

Changeovers, putting up and taking down work, will be organized and scheduled by the curator at Berkshire Hathaway's staff's convenience.

Display Areas: 4 walls with white paint, hanging system, and excellent lighting. Curator will hang the show, bring your work at the scheduled date or drop off at the Bothwell Art Center after contacting Jen Huber at 858.361.5724 or jen@jenhuberart.com.

Labeling: The curator, Jen Huber will make and hang the labels using museum putty and card stock.

Sales and Commission: Sales are to be conducted through the artist, so ensure that you have your contact information clearly stated on your artist statement and/or label. If you have a suitable replacement artwork, which will benefit the show, you may sell the artwork directly. The artist is responsible for pickup/replacement of sold works.

* A 20% commission is charged and all money goes to AVA to help maintain AVA the Downtown Art Stroll project. Commissions are due at the end of the show and checks should be made out to **Alliance for the Visual Arts**. Checks and commission form can be mailed to:
