3	Complete the Sponsorship Agreement	A straightforward agreement will be provided outlining your selected benefits, our mutual commitments, and any custom provisions. Agreements are typically completed within one week.
4	Submit Payment	Payment is accepted via check (payable to Dominion Riders Foundation), ACH/wire transfer, or online payment portal. Payment plans may be available for Platinum and Legend sponsors — ask us for details.
5	We Handle the Rest	Our team will collect your logo, preferred messaging, and contact information to ensure your brand is accurately and professionally represented across all agreed-upon materials and channels.

Tax Documentation: All sponsors will receive a formal confirmation letter acknowledging their tax-deductible contribution for 501(c)(3) IRS reporting purposes, issued within 30 days of payment receipt.
