1 ASCA Sanctioned Obedience Trial and 2 ASCA Sanctioned Rally Trials

Obedience Trial starts at 8:00am. Rally Trial 1 starts at 10:00am or after obedience trial. Rally Trial 2 starts at noon or after first rally trial. Trial site opens at 7:00am.

Judges: Gail Stone – Dresden, ME, all rally classes
Marcia Dawson – Waterford, NY, all obedience classes

Pre-entry: \$25 each class, \$18 second class (same dog, same trial)

**Package- enter at least 1 class in each of the 3 trials and pay \$60 for those 3 classes. **

Pre-entries open February 17, 2026, and close on March 16, 2026, or when total entry limit has been reached.
Total entry limit of 70 runs for the day. No refunds after pre-entry closing date.

Classes Offered:

Obedience (in order)- Utility B/A, Open CDX B/A, ODX B/A, Novice B/A/C, Grad Novice, Beginner Novice B/A and Sub Novice

**Novice group exercises will be held before novice individual exercises. Veteran dogs will show in regular classes and are allowed to jump 4" lower.

Rally (in order)- Masters B/A/C, Excellent B/A/C, Advanced B/A/C, Novice B/A/C.

ASCA Information and Rules:

These are ASCA sanctioned trials, no food or corrections are allowed. The event is open to all breeds and mixed breeds. All breeds are eligible for titles. No bitches in season. Bitches that come into heat or dogs that become injured before the pre-entry closing date may have their entries refunded pending proof by veterinarian.

All dogs must have proof of rabies vaccination at the trial.

An ASCA registration # or tracking number will be required.

This event will follow all rules and regulations of the Australian Shepherd Club of America. For a copy of ASCA rules go to: <https://www.asca.org> .

No entry will be accepted from a dog or handler disqualified from all ASCA programs, or a person not in good standing with ASCA.

Dogs with titles or legs in other registries must begin at the novice level in ASCA.

A displaceable jump will be used in this trial.

Awards:

1st through 4th place placement ribbons per class. Green qualifying ribbon for each qualifier. High in Trial will be awarded for each obedience and rally trial from the regular titling classes only. High Scoring Aussie or High Scoring Other Breed (if not high in trial), High Combined and High in Trial Junior will be awarded at each trial.

High in Circuit prize will be awarded to the dog/handler team with the highest average score for the weekend.

Scores must come from regular titling classes.

Location Information:

The trial will be held indoors on turf. All crates and chairs must have mats underneath. No X-pens permitted inside. Please pick up after your dog. There is a \$30.00 cleaning fee. No outdoor shoes allowed on turf, please bring second pair of shoes to wear on turf.

Directions to Working Dogs NY LLC:
