### Directions to Wolf Mountain Kennel:

From I-87- Take exit 7 for NY-7 E toward Troy/Cohoes. Continue onto NY-7 E (past Popeyes Louisiana Kitchen). Continue straight (enter Vermont). Keep left at the fork, following signs for US-7 N. Keep right at the fork, following signs for US-7 N. Merge onto US- 7 N. Turn left onto Raymond Rd (be on the lookout for Mt. Tabor Country Store as Raymond Rd will be 1.5 after the store). Go approx 0.5-0.6 miles and turn left onto Staples Rd (it's a hairpin turn). The address for Wolf Mountain Kennel is 704 Staples Rd (destination will be on right). The address for the Wolf Mountain Kennel pool is 570 Staples Rd. The driveways can be seen from one another.

\*\*If you are coming from the North on Rt 7- You will be making a right onto Raymond Rd. (be on the look out for White's Fuel Stop. Raymond Rd will be approx 0.7miles from the truck stop). Please note that the turn for Raymond Rd is poorly marked. There's not a sign on Rt 7 that says Raymond and the only sign you may see is for the Cascades.
