### Terms of Agreement

1. Minimum deposit of \$ \_\_\_\_\_ is required.
2. Any deposit received in non-refundable and will go towards payment of services.
3. Parties entering into this contract are permanently bound to fulfill the obligations by this agreement unless one or more of the following conditions apply:
  - a. Both parties mutually agree to leave the agreement and its responsibilities.
  - b. The event described herein is completely cancelled.
4. In the event that the event is cancelled, or D.J services are cancelled by client, the client will be charged a \$50.00 fee.
5. In the event that Megan Grassel becomes unable to provide her services due to complications beyond her control, a reputable replacement shall be provided at no more than the original price agreed on.
6. It is hereby further agreed; that the Client shall be held liable and fully responsible for any damages to the property of the DJ, while on the premises of said engagement, if damage is caused by Client or guest, members of her organization, engagement invitees, employees, or any other party in attendance, whether invited or not.
7. The parties purchasing the services of Music that Moves (Megan Grassel) agree to allow Music that Moves to use pictures and video images taken at this event for promotional purposes.
8. Music that Moves (Megan Grassel) has the right to have an assistant D.J that she may bring for any help she may need for larger events.
9. If the event exceeds 5 hours, a meal shall be provided to Music that Moves (Megan Grassel) and her assistant.
10. Music that Moves (Megan Grassel) agrees to perform at the date, time and place specified. Music that Moves (Megan Grassel) shall furnish a complete sound system and a selection of recorded music as requested by the Client at the time and location specified.
11. For outdoor performances, the Client shall have overhead shelter either set up or ready to be set up in case of inclement weather. The DJ reserves the right, in good faith, to stop or cancel the performance should the weather pose a potential danger to him, the equipment, or audience. Every effort will be made to continue the performance. However, safety is paramount in all decisions. The DJ's compensation will not be affected by such cancellation
