

MESSAGE FROM THE ARTISTIC DIRECTOR

Dear Friends and Supporters of UVCC, Welcome to Una Voce Chamber Choir's presentation of *Intimations of Immortality*. The title, taken from William Wordswroth's 'Ode: Intimations of Immortality' (and which is excerpted by Tarik O'Regan in the final movement of Triptych), is meant to suggest the ways in which we sense the divine and eternal that surround, inhabit, and comfort us. Born at my kitchen table in the winter of 2019 when Drew Albert first suggested the Triptych as the centerpiece of a future concert series, this program has had a long and interesting journey these past three years...as have all of us.



Originally intended for performance last year, Intimations necessarily went onto the back burner as UVCC shut down operations at the start of the pandemic. It has nonetheless remained firmly fixed in the imaginations of our artistic team; there was never any question that when UVCC was finally able to return to our work, it would be with this collection of music and poetry. Like all great art their meanings have evolved for me; not because they have changed (they haven't), but because I have.

Experiencing our shared trauma during this pandemic has deepened my understanding of this poetry and the musical choices of these composers. The exuberance of Rabinadranath Tagore's 'song offerings' is mirrored by Gwyneth Walker's dance-like setting. The economy of musical language in Alice Parker's Heavenly Hurt suggests the depth and intimacy of Emily Dickinson's interior world. Tarik O'Regan's masterful fusing of the rhythms of Western popular music and North Africa provides a perfect palette for the juxtaposition of the poems of Wordsworth, Al-Bayoumi, Milton, and Rumi. Ola Gjeilo's Song of the Universal captures the grandeur of Walt Whitman's Leaves of Grass. It is our hope that in their sharing you are moved, inspired and comforted in your own way.

I will close by offering my heartfelt thanks to the Una Voce family. Their commitment, hard work, musicianship and friendship has made this return, and this program possible and this semester magical.




