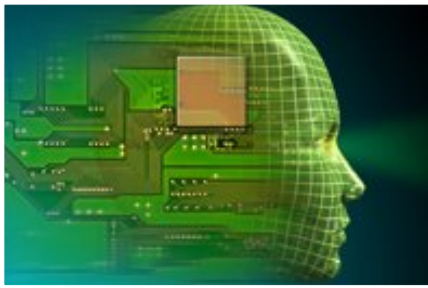
What is a vaccine, and what is it not?

While the Industrial Revolution was not absolutely necessary for, nor was the it the cause of, the rise in popularity for each of these movements - it did serve to amplify their influence.

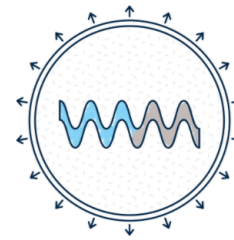
So what small movements might explode in popularity during the next technological revolution?

At the very top of the screen, surprise!! It states, “The Moderna COVID-19 Vaccine has not been approved or licensed by the US Food and Drug Administration (FDA), but has been authorized for emergency use under the Emergency Use Authorization (EUA), to prevent Coronavirus Disease 2019 (COVID-19) for use in individuals 18 years of age and older. There is no FDA-approved vaccine to prevent COVID-19”

Additionally, if you keep scrolling down that page, it essentially tells you the same thing Pfizer does about their mRNA injection, and that it does NOT contain any virus. Keep scrolling and take a look at the potential side effects they now have listed to include myocarditis (inflammation of the heart that leads to heart failure).

Our Operating System

Recognizing the broad potential of mRNA science, we set out to create an mRNA technology platform that functions very much like an operating system on a computer. It is designed so that it can plug and play interchangeably with different programs. In our case, the “program” or “app” is our mRNA drug - the unique mRNA sequence that codes for a protein.

We have a dedicated team of several hundred scientists and engineers solely focused on advancing Moderna’s platform technology. They are organized around key disciplines and work in an integrated fashion to advance knowledge surrounding mRNA science and solve for challenges that are unique to mRNA drug development. Some of these disciplines include mRNA biology, chemistry, formulation & delivery, bioinformatics and protein engineering.

Wait, what? An “operating system”? A “platform technology”? If this causes you to pause, it should. We are biological humans not machines. Why is it then that they would inject humans with an operating system?

Transhumanism and Patentability

Most businesses are in the business of making money. When someone has a great new novel idea, they seek to have it patented so that no one can “steal” or gain profit from their intellectual property and research. Makes sense, right? Botany

Digitalis is typically a biennial plant but may be annual or perennial depending on the species. It is characterized by a thick, cylindrical, downy stem that reaches a height of up to 2 m. Leaves form a thick rosette during the first year of growth. The leaves, which are woolly, veined, and covered with white hairs on the underside, have a very bitter taste. Flowers grow in the first or second year, depending on the species, and are tubular and bell-shaped, growing to 8 cm in length. Many colors of flowers have been bred from digitalis, and they are rarely white. property information” essentially. So anyone can synthesize their own version to sell and make a profit. Well, Digoxin is actually based on a plant called Digitalis, found in nature. But in order to patent a drug utilizing the foundations of the medicinal properties of this plant, the pharmaceutical companies had to synthesize it and combine it with

other elements to make it effective in treating congestive heart failure without being toxic, as it is in its’ natural form. So what does this have to do with Transhumanism?

Transhumanism, as opposed to humanism, is a philosophy that essentially believes that humans can be improved upon and that our evolution can be altered to make these improvements. 1. The intellectual and cultural movement that affirms the possibility and desirability of fundamentally improving the human condition through applied reason, especially by developing and making widely available technologies to eliminate aging and to greatly enhance human intellectual, physical, and psychological capacities.
2. The study of the ramifications, promises, and potential dangers of technologies that will enable us to overcome fundamental human limitations, and the related study of the ethical matters involved in developing and using such technologies.

Transhumanism can be viewed as an extension of humanism, from which it is partially derived. Humanists believe that humans matter, that individuals matter. We might not be perfect, but we can make things better by promoting rational thinking, freedom, tolerance, democracy, and concern for our fellow human beings. Transhumanists agree with this but also emphasize what we have the potential to become. Just as we use rational means to improve the human condition and the external world, we can also use such means to improve ourselves, the human organism. In doing so, we are not limited to traditional humanistic methods, such as education and cultural development. We can also use technological means that will eventually enable us to move beyond what some would think of as “human”.

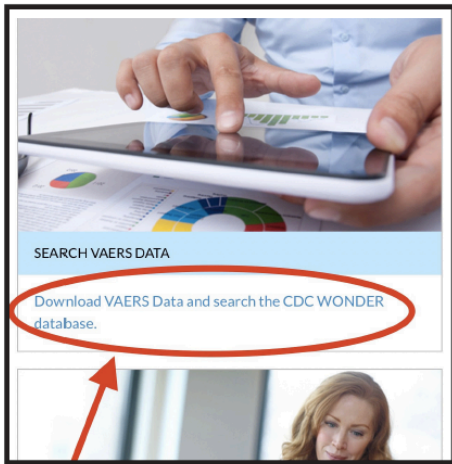
(Johnson & Johnson) or Astra Zeneca and is JUST for the United States. The United Kingdom also has a tracking system called the Yellow Card system. But these are only two countries of the 195 countries around the world, most of which do not have any reporting system at all.

Safe and effective, my ass!

Unfortunately, since the last time I looked at this prior to today, the system limits the report to 10,000 rows. In order to re-run the search to get a response, I limited my search to deaths only and then also by sex. As of the date of this Newsletter July 7, 2021, the **Moderna** related **deaths** reported in this system were females: 10, 758 and males: 11, 906. The **Pfizer** "vaccine" related **deaths** were males: 13, 065 and females: 10, 958. **This is just the deaths**, and does not the adverse events or disabilities created by these injections of poison such as neurologic disorders, blindness, deafness, cardiomyopathy, and other debilitating effects. 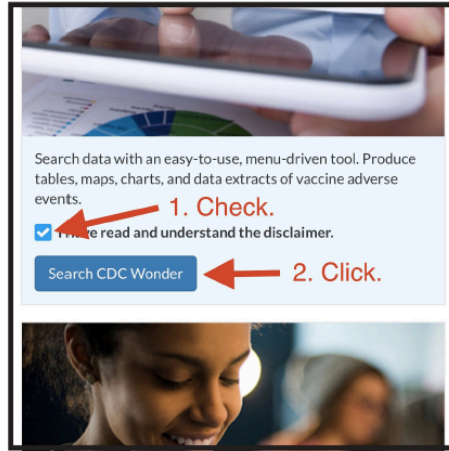
Step 2

Scroll halfway down the page and click the link circled below.



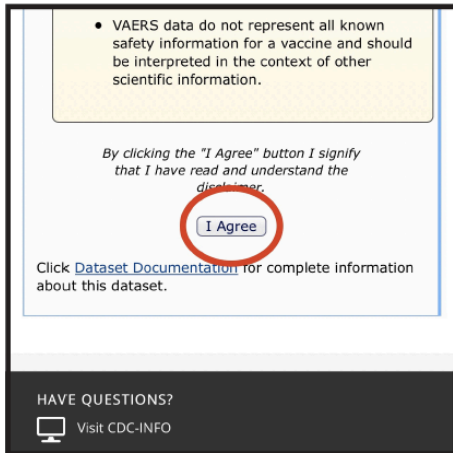
Step 3

Scroll down once more, click the check mark, then click search.



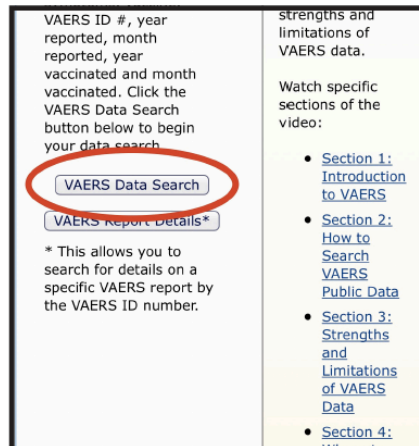
Step 4

Step 5

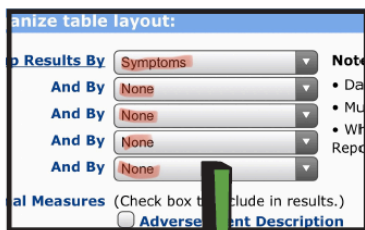
Next, scroll halfway down the page and click "VAERS Data Search."



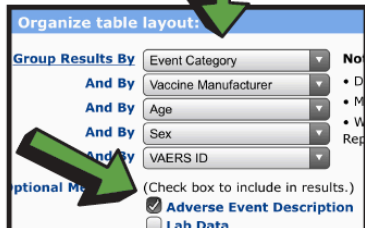
Step 6

These are the first parameters you need to change. The red highlights are the defaults. I chose the options below. This report will sort the adverse events by the below selections.



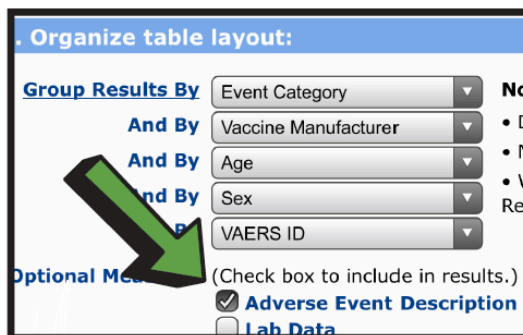

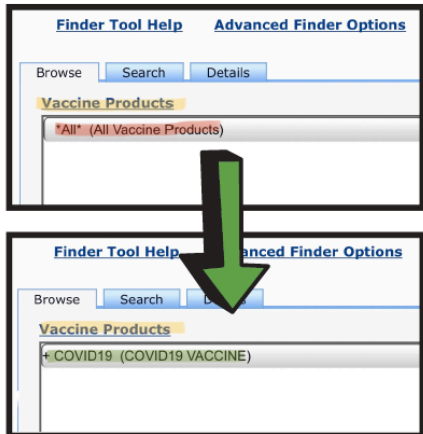

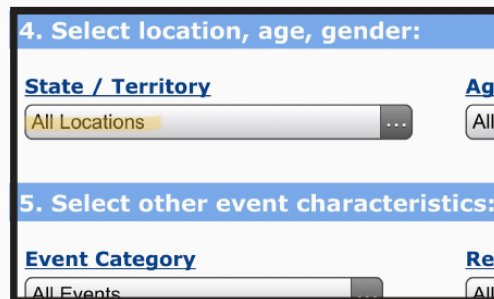
Because there are now so many CV19 vaccine Adverse Events that have been reported to VAERS, you cannot run even a standard report as VAERS only allows 10k rows. We have to limit one of the "Group Results" now. I will show you how to do this in the next couple of slides.



Scroll down to "Vaccine Products," unselect "All" and select "COVID-19."



Change "US Locations" to "All Locations" (it's still only US citizens).



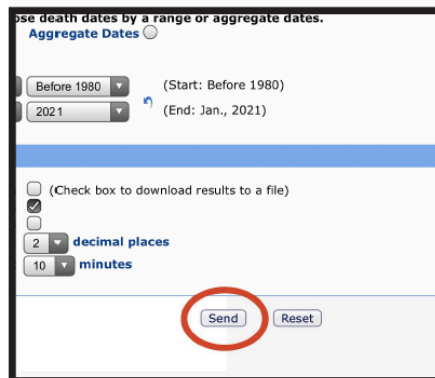
Limiting Results

There are many ways to limit VAERS reports on the Parameters page. You can limit by vaccine manufacturer, state, age, sex, etc. For this report, we will limit the Event Category by "Death" and "Permanent Disability."

1. Scroll down to and click on "All Events" under "Event Category."
2. Unselect "All Events" and Select "Death" and "Permanent Disability."



Scroll down to the bottom of the page and click "Send."



This should generate a report with your selected parameters.
