New Lower Oldpark Street Named

The new street being created as part of the social housing scheme at Alloa Street has been named.

The developer, Clanmil Housing, notified LOCA recently that Belfast City Council (BCC) has decided that the new street will be called Annalee Street.

LOCA carried out a community consultation on what street name should be used. The most popular choice among residents was 'Annalee'. BCC selected 'Street'. It is good that BCC took on board the views of local people.

Some residents will recall that the previous name of the street that existed before the houses were demolished was 'Annalee Court'. Before Annalee Court was built in the 1980s, there



were rows of old terraced housing streets, one of which was called 'Annalee Street'. The naming of the new street restores an old street name.

We're all looking forward to seeing Annalee Street brought back to life.

Building work is progressing well and on target for completion in September 2024.

New Lower Oldpark NIHE Patch Manager

Patch Managers are a single point of contact in a specific geographical patch e.g. Lower Oldpark. They deal with

things like:

- New tenancy sign-ups.
- Transfer and mutual exchange applications.
- Rent account matters.
- Planned maintenance schemes.
- Payments from the NIHE.
- Tenancy succession and assignment and joint tenancies.
- Anti-social behaviour and community safety issues.
- Managing empty NIHE homes.

NIHE Heating Adaptations

If you, or someone in your household, has a disability and live in a NIHE property, it can assess any heating changes you may need.

This might involve replacing an open fronted fire or glass fronted solid fuel fire with gas, oil or electric fire heating.

Initial Enquiry

Initial Checks

The NIHE Area Office staff will carry out some checks to ensure that you live in the property and that you have not applied to buy your home or for a transfer. They will also check what heating system is in the property and whether or not it is included in a heating replacement programme.

If your home has been included in a

heating replacement programme, you will be advised of the start date.

Heating Evaluation Form

The NIHE Area Office staff will send you a heating evaluation form. This form must be completed and returned to your local Housing Executive Area Office. The form will then be checked before being sent to the Area Welfare Officer.

Client Need Assessment

The NIHE Area Welfare Officer will check your change of heating request against the following criteria:

- You must usually be over 18 years of age.
- You must have a permanent and severe disability and problems using the heating system.

This may involve a home visit from the Area Welfare Officer.

Priority of Case

If you meet the criteria and have been approved by the Area Welfare Officer, your case will be given a priority rating.

You will be told of the priority of your

case by letter. The categories are listed below:

Standard

The person with a disability has an able-bodied person at home for most of the day.

Standard Plus

The person with a disability does not have an able-bodied person at home for most of the day.

Urgent

The person with a disability does not have an able-bodied person at home for most of the day and is:

- Unable to be released from hospital, residential care or will have to go into care until heating is changed and/or;
- Is at risk, creating danger to themselves or others unless the heating is changed to a nonmanual system.

Urgent cases will be dealt with on an individual basis as quickly as possible.

You will be told when the work to fit your new heating system will start.

Problem With Mortgage Arrears

Most people will buy a property by means of a mortgage, which is a loan taken out to buy a house or apartment, from a bank or building society. The amount borrowed is secured on the property. This means that the lender can go to court to obtain possession of the property if the borrower fails to make the required repayments.

Affordability

One of the big issues facing homeowners is affordability. In recent

years there has been a dramatic increase in the number of home owners in Northern Ireland under threat of losing their homes because of debt.

Possession

Non-payment of the mortgage on a property may lead the lender to seek possession of the property.

Help

Anyone facing difficulties in paying their mortgage should seek specialist advice as soon as possible.

NIHE Tenant Rent Arears – What To Do?

If you don't pay your rent, or pay it late, the money that you owe is called rent arrears. If you are in arrears you should contact the local NIHE Patch Manager, Martin Coney (028 95982748), right away.

The NIHE can help by:

- Having your rent paid from other benefits.
- Having your arrears paid alongside your weekly rent payments. The NIHE will offer constant support during this time.
- Having your rent paid directly from your salary.

The NIHE can set up an arrangement to help you monitor your payments and notify you if you don't make a payment.

Anti-social behaviour (ASB) covers a wide range of unacceptable activity that may cause harm to an individual, to their community or to their environment.

This could be an action by someone who leaves you feeling alarmed, harassed or distressed and impacts your quality of life.

Anti-social behaviour might include:

- Violence or threats of violence.
- Hate behaviour that targets members of identified groups because of their perceived differences e.g. race, religion, political affiliation, disabilities or sexual orientation.
- Noise nuisance e.g. rowdy parties, loud music/TV, dogs barking etc.
- Arguing and slamming doors.
- Environmental issues e.g. litter, dog fouling, graffiti, fly tipping, nuisance vehicles.
- Offensive drunkenness.
- Using a dwelling for unlawful

- Assault.
- Criminal damage.
- Disorderly behaviour.
- Drink/drug related offences.
- Harassment.
- Breach of the peace.

If you report an incident to the police, remember to ask for an incident number. You may need this later if the ASB means that you feel you can no longer live in your home and want to be rehoused by the Housing Executive.

NIHE Finally Tidies New Planted Areas

New planted areas provided as part of the Department for Communities Courts' Project have, after a very long delay, been tidied up by the Northern Ireland Housing Executive (NIHE).

Despite requests from LOCA, the NIHE allowed the planted areas to become overgrown with weeds and covered in litter.

It is good to see new grass, bark ground cover and plants in place. Let's hope NIHE Grounds' Maintenance look after it in the future.

Oldpark Road Public Realm Scheme Progress Awaited

Details of whether, or when, public realm improvements on the Oldpark Road frontage from near its Crumlin Road junction to Cliftonville Circus are still awaited.

The planned improvement, which date back to 2017, received planning approval in 2019 but were put on hold. They were revived last year and it is hoped work starts before April 2024.

LOCA contacted the Department for Communities, which is responsible for the scheme, for an update. A representative said that, 'DfC is currently consulting with DfI regarding their active travel requirements (cycle lane provision) for this area. The outcome of these discussions will then dictate the way forward for the Lower Oldpark Public Realm scheme and subsequent work programmes and start dates etc.'
