Dear Chapter 35 Member;



The word from Texas and the Nationals is that Erik Fleming of Chapter 35 finished 6th in Sportsman out of 17 contestants. Mike Goulian finished 19th in Intermediate out of 26 competitors. We had another, J. Eiland, listed as a Chapter 35 member finish 16 in Sportsman; but neither Ward nor I can remember him and he's not on our membership list.

There were 37 entrants in the Unlimited category. Diane Hakala competed for the first time at the Nationals but didn't make the team.

It appears as if we pulled it out of the fire again. If we don't include our "hats", we just about broke even on our Non Contest. We expect to get our insurance refund, (and that is included in our totals) We'll be \$600 short if it doesn't arrive. All of this was made possible by all the fine people that donated their entire entrance fee to the chapter. We were very lucky.

The business meeting that proceeded flying covered the usual notices. Some of the people around the US are having problems with the new EAA

regulation beginning in 1988 that all chapter members must belong to the National organization. Personally, I don't have any problems with this. I think the ones that don't, within a reasonable time, have been getting a free ride long enough.

I also made the announcement that I will not be a candidate for any office in Chapter 35 for 1988. After 14 years as either President or Vice President, I'm going to take some time off and just come and enjoy myself. We need a President, Vice President and Secretary-Treasurer for 1988. Since we don't have a nominating committee, it is going to be difficult to have an election. We are going to try something new and there will be a ballot at the end of this newsletter. Cut it off and fill it out and mail it or bring it to the next meeting (Oct. 24) and then all ballots can be counted and the lucky person can either accept or refuse the job.
