# NOTES ON THE LAST MEETING

The March meeting was held on Saturday, March 19, at Daniel Webster College, Nashua Airport Tower Building. Thirty-three members and guests were in attendance. During the business meeting, there was considerable debate on three items.

First, there was the proposed amendments to the IAC bylaws that would have the officers of IAC elected by the Board of Directors rather than elected by the membership. Several members have already written carefully composed letters to headquarters on this issue. After considerable discussion, a vote was taken. The members of Chapter 35 were overwhelmingly against the proposed change.

Second, there was the issue of IAC's relationship with EAA. EAA seems to feel that IAC is placing too much emphasis on competition and not doing enough to support the parent organization. On the other hand IAC seems to feel that EAA is wants too much control over IAC. The positions of both organizations seem a bit fuzzy. The general consensus seemed to be that being part of EAA has a lot of advantages and that we should try to work out our problems with EAA. A vote was

taken. The members of Chapter 35 were overwhelmingly against severing IAC's relationship with EAA.

Finally, there was the question of Chapter 35's support of the U.S. Aerobatic Team. On the table for consideration was a letter from the U.S. Aerobatic Foundation requesting the each IAC chapter donate \$500 to the team. The ensuing debate centered around how much we should donate and whether our donation should come out of the treasury or from special contributions from individual members. Several members spoke persuasively in favor of both methods. A vote was taken. It was decided that special contributions would be solicited from the membership and combined with a modest contribution from the treasury and forwarded to the U.S. Aerobatic Foundation in the name of Chapter 35. Approximately \$100 was collected at the meeting. Additional contributions will be solicited through the newsletter. See the next newsletter item.

Following the business meeting, IAC 35 pilots Mike Goulian, Erik Fleming, Paul Voegtlin and Rick Runnels gave us their views on the 1988 IAC Known Sequences. Their presentations were excellent and there were many questions from the floor on how certain maneuvers should be flown. We will probably have similar "hangar flying" sessions in the future.

The World Aerobatic Championships will be held this late this summer in Red Deer, Alberta in Canada from July 31 through August 12. The United States will be sending both men's and a women's teams to the event. The team has asked for and deserves our support. # IS YOUR PRACTICE AREA STILL LEGAL?

Having problems with 727's flying over or through your favorite practice area? Well in case you haven't noticed, the FAA recently implemented their new East Coast Plan which relocated many airways and intersections. THESE CHANGES ARE NOT SHOWN ON THE CURRENT NEW YORK SECTIONAL. The easiest way to see if your practice area is still legal is to check the current Jeppesen Low Altitude Enroute Charts. Remember, airways are 8 nautical miles wide, 4 miles on each side of the centerline. RECHECK YOUR PRACTICE AREA and make sure it's still legal!



## 1988 MEMBER SURVEY RESULTS

Forty members responded to the 1988 Member Survey Questionnaire. Complete results are attached. When looking at the results, you may notice anomalies in the total number of answers received for certain questions. This was caused by the fact that some people did not answer all of the questions.

Of the people who responded to the questionnaire, 88% own aerobatic airplanes while only 53% have flown in an IAC contest. Approximately 71% of the people who have not flown in an IAC contest are planning to do so in the future. Although about half of the respondents have attended an IAC judge's school in the past, three quarters expressed interest in attending the Chapter 35 judge's school tentatively scheduled for March of 1989.

The officers of the chapter wish to thank all of you who took the time to fill out and return the questionnaire. We received many good comments and suggestions and we are planning to act upon as many of them as possible.

#### JUDGE'S SCHOOL SCHEDULED FOR MARCH 1989

In response to the Interest expressed by those members who responded to the Member Survey, Chapter 35 is planning to hold an IAC Judge's School in March 1989. 


