THIS YEARS CONTEST

To start off the aerobatic season, this years N.E. Aerobatic Championships will be held at the Orange Municipal Airport in Orange, Massachusetts on May 8, 9 and 10, 1992. This date was typically reserved for the Orange County Chapter 52 contest in New York and the Canadian Chapter 3 contest in Ontario. However, these chapters will not be holding aerobatic contests this year. This opened up the opportunity for us to use this Spring date.

Chapter 35 has just received FAA approval for an aerobatic box at Orange. Approval for the contest has been granted by the Orange Airport Commissioners. They are enthusiastic about having us but emphasised that we are on a trial basis. This means that we have to be on our best behavior to insure future usage. Orange is ideal for a contest because of its runway and taxiway alignment. The ramp area is more than adequate in size, security and safety.

INTERESTING NEWS

In mid-December, Erik Fleming and myself attended a speech given by Patty Wagstaff at the Smithsonian Air and Space Museum in Washington, DC. Patty gave a lecture on professional aerobatics, which detailed both air show and competitive aerobatics.

Through the efforts of a close friend, we were given a comprehensive tour of the Smithsonian's Silver Hill facility which does all of their restoration work. We were able to view the aerobatic aircraft of past greats Art Scholl, Betty Skelton, and Bevo Howard.

While in Washington I ran into Augie and Ruth Bohn's daughter, Marta Meyer. She told me that she and Bob are currently flying the high flying Lockheed SR-71 Blackbird which was purchased by NASA. They have flown through its entire speed and altitude envelope. She reports that the vertical performance is breathtaking but that rollers and outside snaps can be difficult above Mach 2.5 (just kidding, Mr. NASA).

Mudry Aviation in France has flown a new and modified version of its popular CAP 231. This new aircraft has a wing built by Walter Extra of Germany. A stronger wing and increased fuel capacity are just some of the new features.

John Staudacher of Michigan and Dan Rihn of California are currently in the final phases of a new, lower cost aerobatic monoplane to be built by Staudacher Hydroplanes in Kawkawlin, MI. This new bird will be constructed entirely of wood similar to the CAP 231, have 200hp, a fixed pitch prop and will weigh in at 1,000 pounds. Performance is expected to exceed the Extra 230 and other "Laser" types. This aircraft came about as a result of the diminishing use of the bi-plane and the high price of the aircraft produced in Europe. Price is expected to be in the high 70s.



Patti Nelson, Randy Gagney, Collins Bomar, Ray Williams, Debbie Rihn and Mike Smith are Directors of the ACA. The three year terms of Debbie Rihn and Mike Smith expire on October 1st of this year. Both Mike Smith and Debbie Rihn would like to be re-elected. The election will be held at the annual meeting where additional nominations may be made from the floor.

In the ACA the Officers are elected by the Directors and the new Board of Directors will meet immediately after the Business meeting to elect the officers and conduct any other business as needed.
