- 1) The student will receive service based on request and payment

 - 6-hour drive session
 - Permit Testing

- 2) Tuition for the complete course of driver training is \$300.00. This includes classroom instruction training \$120.00 and Behind the Wheel Training (6 hours) \$180.00. Tuition is subject to change, if additional BTW training is requested or needed at \$75.00 per 2-hour minimal will apply. Tuition must be paid in full upon scheduling for training. Cost for Driver Training 6-hour BTW is \$240.00. Permit Testing cost \$15.00 for non-complete course students and for complete course or drivers training student there is no additional cost for permit testing. Permit testing is based on availability of examiner.

- 3) Driving instruction classes are modified at this time due to COVID-19 and to be compliant with the CDC guidelines – each student that has not been vaccinated will be requested to wear a mask. Social distancing is still required for classes. Virtual classes may be required for future classes. If the student is experiencing signs and symptoms of COVID-19, they will need to be rescheduled for a later date. It would be recommended that the student be checked by a medical provider before returning to class. Hand sanitizing is required upon entering and exiting the classroom as well as before entering vehicle and at the completion of the driving session. Hand sanitizer will be provided by the academy.
- 4) Tuition for this course is **NON-REFUNDABLE**. Payment can be made by Credit/Debit card online at www.SandADrivingAcademyllc.com or

 - o There is an electronic payment processing fee charged by carrier for use of all credit cards and Apps (Cash App, PayPal, etc.) transactions.
- 5) In the event that ANY paperwork (PDLA form, certificate, etc.) is lost or misplaced, a service fee of \$20.00 will be charged to replace the item.
- 6) Driving appointments for above-named student will be scheduled depending on the **AVAILABILITY** of S&A instructors, weather conditions, and subjects to all fees being paid in full.
- 7) **Cancellation** of driving and testing appointments must be made at least 48 hours before scheduled appointments. Also, if a student is more than fifteen (15) minutes late for a scheduled appointment constitutes as a cancellation/no-show. A student will be charged \$30.00 for cancellation (or if a driving slot is vacated), the client forfeits that driving time of two hours. If notification is not made before the 48-hour period, the contract will **be cancelled and no refund of paid monies.** *
- 8) Student and parents (legal guardians) will be responsible for any damage to automobile Kia Spectra (if not in the ordinary course of driving with instructor), classroom and materials. Students will complete a vehicle inspection each time they are BTW. The type of vehicle being driven is an automatic transmission with an extra brake pedal.
