Day of show entries will be taken immediately following Best in Show, Thurs-Sat, for 15 minutes

All entries must be on a current ASCA entry form. Please fill out a <u>separate</u> entry for juniors and conformation classes. Any dog over 6 months must have a permanent ASCA number.

## This show will be held under the current rules and regulations of ASCA.

No entry shall be accepted from a dog or handler disqualified from the ASCA conformation program; a dog or handler disqualified from all ASCA programs: or a person not in good standing with ASCA.

\* Entry fees will not be refunded if the dog is absent, disqualified, excused, or barred from competition by the show committee, ASCA, the show veterinarian, or the judge. ASCU, their BOD, ASCA, its BOD, and the property owner assume NO RESPONSIBILITY for any loss, damage, or injury sustained by exhibitors, handlers, or to any of their dogs, personal property, and/or children.

**Facility Accommodations:** The show will be held at the Cache County Fairground across the street from the pool and next to the cinderblock building. The facility is outdoors with space available for setups. The footing is grass. Be prepared for any weather. Parking is available for free on the street or for a small fee inside the fairgrounds.

Turn right onto W 600 S. Turn left onto Park Ave. Turn right onto W 400 S. Turn right onto S 500 W. Arrive at Cache County Fairground.
