All entries must be on a current ASCA entry form. Please fill out a separate entry for juniors and conformation classes. Any dog over 6 months must have a permanent ASCA number.

This show will be held under the current rules and regulations of ASCA.

No entry shall be accepted from a dog or handler disqualified from the ASCA conformation program; a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA.

** Entry fees will not be refunded if the dog is absent, disqualified, excused, or barred from competition by the show committee, ASCA, the show veterinarian, or the judge. ASCU, their BOD, ASCA, its BOD, and the property owner assume NO RESPONSIBILITY for any loss, damage, or injury sustained by exhibitors, handlers, or to any of their dogs, personal property, and/or children.*

Awards: Ribbons 1st – 4th Place & Rosettes

Facility Accommodations: The show will be held at the Utah State Fair Park in the Market Building, 155 1000 W., Salt Lake City UT. The facility is indoors with electricity and indoor grooming and setup space available. The flooring is rough concrete. There are inside heaters, but plan on cooler

temperatures. The ***grounds will open at 8:00 AM*** the morning of the show.

Driving Directions:

From I-15 Northbound and Southbound: Exit I-15 at 600 North, Exit 309. Proceed west to 1000 West. Turn left and proceed south to Fairpark (approximately four blocks).

From I-215 Northbound and Southbound: Exit I-215 at 700 North, Exit 23. Proceed east to 1000 West. Note: 700 North curves and turns into 600 North. Turn right at 1000 West and proceed south to the Fairpark (approximately four blocks).

From I-80 Eastbound: Exit I-80 at Redwood Road. Turn left and proceed to North Temple (approximately three blocks). Turn right and proceed east on North Temple to Fairpark.
