RV & Golf Cart Repair Release Form

I hereby acknowledge that I understand the inherent risks and potential liabilities on having my RV or Golf Cart's repair(s) undertaken. I likewise declare that I have full and legally binding authority to provide consent for the repair of my RV or Golf Cart on my premises or campground site. I acknowledge the risk of any possible damage that may be incurred during the repair of my RV or Golf Cart and by which I assume the liability and responsibility of such damage. I hereby authorize the company to perform all necessary and authorized repairs to my RV or Golf Cart. In this regard, I understand that they may bring heavy equipment for the purpose of the repairs as quoted and discussed with me. I hereby express my permission for the Company to use my premises or campground site to park their vehicle and heavy equipment and assume the potential risks and liabilities associated with such activity on my premises, including any damage to the property whether real or personal.

The following has been explained to me and I acknowledge with full understanding:

- There is a risk of spill of oil, grease, and/or other chemicals that may spill onto my campsite, driveway, lawn, garage and/or any other personal property.

_____ I understand and agree

- It is my responsibility for keeping away children, pets, relatives and guests away from the work area during the repair in order to avoid or mitigate the risk of personal injury.

_____ I understand and agree

- I take responsibility for any damage to any property within the premises or campground site, whether real or personal, particularly including but not limited to, my driveway, landscaping, home, and/or personal injury, might occur.

_____ I understand and agree

- The time spent in repairs through this method may take longer than usual. I accept and acknowledge any unforeseen delays or expenses which may accrue for not having the RV or Golf Cart repaired on time.

_____ I understand and agree

- During repair, there may be unforeseen damaged parts that the technician might not see and might get damaged. The technician shall inform me of these damaged parts and further assessment shall be made. This may incur additional costs for repair on my part should I ask for it to be repaired as well.

_____ I understand and agree

I hereby waive my right to sue the Company for any and all damages, injuries, or death that I or my family might incur during and in connection with the repair of my RV or Golf Cart. Further, I hereby defend, indemnify, release, discharge, and hold harmless, the Company, its owners, affiliates, employees, agents, and representatives from any liability, injury, loss, damages whether personal or real, expenses, whether tangible or intangible, litigation costs by which they may incur in relation to the repair of my RV or Golf Cart in my premises. I hereby declare that I am at least Eighteen (18) years of age and the legal and registered owner of the RV or Golf Cart, Premises, registered guest of the campground site location and have the full authority to sign this agreement.
