

## ZIMBABWE CAPE BUFFALO HUNT GIVEAWAY

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT, OR ACCEPTANCE OF A PRODUCT OFFER, WILL NOT IMPROVE YOUR CHANCES OF WINNING.

1. **SPONSORS:** The Sponsors of the Ultimate Cape Buffalo Hunt Giveaway are Untamed Knife Company Pvt. Ltd., a Zimbabwe company, (“Untamed”), Dalton & York Safaris, a Zimbabwe company, (“D&Y”), Double Rifle Society, LLC, an American company, (“DRS”), and Safari Specialty Importers, an American company (“SSI”) (referred to collectively as “Sponsors”).
2. **ELIGIBILITY:** The Zimbabwe Cape Buffalo Hunt Giveaway (the "Giveaway") is open to participants worldwide who are 18-years of age or older, except for residents in countries subject to United States export control restrictions and sanctions, countries embargoed by the U.S., and countries that have been designated by the U.S. government as ‘terrorist supporting’ nations” (see the complete list [here](#)), including Afghanistan, Belarus, Burma, Central Africa Republic, Cambodia, Chad, China, Colombia, Cuba, Democratic Republic of the Congo., Ethiopia, Hong Kong, Iran, Iraq, Lebanon, Libya, Myanmar, Mali, Nicaragua, North Korea, Pakistan, Russia, Singapore, Somalia, Spain, Sweden, South Sudan, Sudan, Syria, Venezuela, Yemen, and any other country where local, state, province, or federal laws or regulations prohibit the provision of or entry into a Giveaway. Employees, independent contractors, interns, officers, directors, and agents of the Sponsors, their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers, and their immediate family members and/or those living in the same household of each are not eligible to participate in the Giveaway.

5. HOW TO ENTER:

A. NO PURCHASE REQUIRED ONLINE ENTRY: Internet access required. During the Promotion Period, eligible entrants can enter online at <https://doubleriflesociety.com/giveaways-1> or <https://untamedknives.com/#giveaway>. Five (5) entries will be awarded for every method of entry completed.

6. GRAND PRIZE: The winner(s) of the Giveaway (the "Winner") will receive the following Grand Prize ("Prize"):

A. PRIZE: A free-range 12-day Cape Buffalo safari ("Safari") for one hunter and one observer in the Nyakasanga area of Zimbabwe fully guided by D&Y, and professionally filmed by Untamed. The winner will also receive a complete "Dangerous 6" collection of knives manufactured by Untamed.

1. SAFARI DATES: The Safari will be held in 2026. The Winner will coordinate the hunt dates with the Sponsors.
2. WHAT IS INCLUDED: The following are included with the Safari:
  - a. Round-trip airfare for the Winner from their location to Harare, Zimbabwe.
  - b. The service of a licensed professional hunter, trackers, skinners and camp staff.
  - c. Full board and lodging.
  - d. All meals, soft drinks and alcoholic beverages in moderation.
  - e. Daily laundry.
  - f. Field preparation of trophies.
  - g. Travel expenses within Africa, including an overnight hotel stay upon arrival and departure in Zimbabwe.

- h. All hunting daily rates.
  - i. Trophy fees for two buffalo.
  - j. Professional filming of the safari by Untamed.
  - k. 2% government levy on daily rate.
  - l. 2% government levy on trophy fee.
  - m. VAT on accommodation services.
  - n. Boat hire \$100 per day + fuel costs.
  - o. The management and clearing services fees listed under the First Class Service from Safari Specialty Importers.
3. WHAT IS NOT INCLUDED: Anything that is not expressly included in section 6(A)(2), including the following, are not included in the Safari:
- a. Tips to Professional Hunter, Trackers/ Drivers, Camp Staff, and Cameramen.
  - b. Dip and pack of trophies to their destination.
  - c. International or inland trophy shipping charges, CFW bonded warehouse storage fees, USFW/CITES fees, or applications for CITES Import Permits if a crocodile, lion, leopard, or elephant is added.
  - d. Taxidermy fees.
  - e. Flights and travel expenses for an accompanying partner.
  - f. Personal expenses, additional, gun hires and ammunition use, air charter on request.
  - g. Additional animals harvested.
  - h. Ranger fees for special permit hunts if an elephant, lion, or leopard is added.
  - i. Pre baiting \$450 per day excluding baits.
7. PRIZE VALUE STATED IN U.S. DOLLARS (USD): The Grand Prize is valued at \$50,000.00. Prize consists of only the item(s) specifically listed in the above Prize description. The actual/appraised value of prizes may differ at the time of prize award. The specifics of the prize shall be solely determined by the Sponsor. No cash or other prize substitution shall be permitted except at the Sponsor's discretion. The prize is non-transferable. Substitution of the prize or transfer/assignment of the prize to others or request for the cash equivalent of the prize by the Winner is not permitted.

not specified as paid by Sponsor herein. The value of the prize is taxable as income and if winner is a United States resident they will receive an IRS form 1099; or if winner is a resident of Canada (excluding the Province of Quebec), they will be required to complete a W-8BEN Tax Form (or its equivalent) for the total value of the prize as stated herein. Winners in other parts of the world may be subject to taxes, fees, and income disclosures depending on where the winner resides.
