

Terms and Conditions

When your chosen date is confirmed, a deposit of £50 or payment of full amount will secure your booking, this covers both licensing and insurance for your event. An email confirming you have read and understand these terms and conditions also acts as a binding contract between yourself and Cherry Bar & Events. The remaining balance and any further payments due for additional services/drinks packages must be received as cleared funds not less than 28 days prior to the event date.

Our prices are based on a minimum of 5 hours service time. Should there be a significant change to the opening hours or numbers attending, either more or less, it is a condition of the booking that you inform us at least 14 days prior to the event.

We will under no circumstances provide a draught bar for any event with less than 80 guests, if this is booked and agreed and guest numbers are reduced, we reserve the right to change the bar menu to a bottle bar.

If you are having a PART PAID BAR reverting to cash bar once limit is reached we ask for your chosen amount to be paid 14 days prior to your event. If you are having an OPEN BAR we ask for a minimum of £1000.00 to be paid 14 days before the event with the remaining balance paid on the night.

Cherry Bar & Events require parking for a van and trailer. Sufficient access to the venue prior to the start of the event to provide and assemble the required goods and equipment and time between the closing of the bar and having to vacate the venue to enable all goods and equipment to be dismantled, removed, and loaded into waiting vehicle/s. Please advise us of any access issues (stairs, gravel paths, long walks, etc) in plenty of time so we can allow for extra time/manpower to set up.

Cherry Bar & Events will supply all equipment, consumables, and staff. As standard we supply polycarbonate glassware which is reusable/recyclable. If you prefer real glassware, you are required to hire this yourselves, and we are happy to use what you provide, reverting to polycarbonate glassware if insufficient glassware is available.

If in the unlikely event that we cannot supply your chosen Bar, for whatever reason, we will endeavour to supply an alternative pop-up bar or vehicle.

We always have card terminals available for payment, but due to the remote nature of some venues, connectivity can be an issue, so please advise your guests to bring cash.

At least two 13amp power sockets need to be available at or near the bar for the running of the fridges and equipment.

Cherry Bar & Events will be the sole provider of all beverages at the event unless agreement is made for you to provide your own arrival drinks/table wine, and this MUST be cleared away by the time the bar is due to open. Guests are NOT permitted to bring their own alcohol to the event under any circumstances. If someone is caught drinking their own alcohol at the event,

(Example: A person turns up with a hip flask or a bottle of vodka or beers purchased from a Supermarket) the bar staff will inform you of this, to be dealt with by you appropriately, and reserve the right to close the bar.

It is illegal for anyone under the age of 18 to purchase, attempt to purchase or consume alcohol at the event. We would suggest that anyone who looks or could be thought to be under the age of 25 (challenge 25) brings photographic ID/proof of age with them or we will not be able to serve them.

We will refuse to serve anyone at the event who is or appears to be excessively drunk or uses threatening or abusive behaviour towards staff, or other guests. We will also refuse to serve anyone who purchases or attempts to purchase alcohol for someone under the age of 18 or someone who has previously been refused alcohol by the bar staff.

The decision on such matters will be taken by the bar staff and will be final. The bar staff also reserve the right to close the bar at any time if in their opinion unruly or troublesome behaviour has arisen or is likely to arise within the venue or its environs.

Bar opening times as requested by the client/s will be subject to approval by the relevant authorities.

In the unlikely event the venue and/or the event being refused an alcohol license the booking fee less any costs incurred in the alcohol license application process will be refunded.

When providing a bar at any 18th birthday party we require a parent/guardian to license the event in their name.
