Chairman Bradich called to recess the Regular Meeting of December 11, 2023, at 7:00 PM. Trustee Hoppe motioned to adjourn, seconded by Trustee Barrera. 3 yeas, 1 abstain. Motion carried.

Chairman Bradich called the Regular Meeting of January 8, 2023, to order at 7:01 PM.

Police Chief Coonce led the Pledge of Allegiance.

Marge mentioned that she had gone to a Northland Neighborhood meeting where they had discussed the growing homeless population in the northland area.

Chairman Bradich spoke on the report regarding the need for lights in the Mildred Keeney Park. After reviewing the report, the board approved updating 3 of the lights with LED lights, saving the village \$4.70 per light each month. Village clerk suggests getting a better print out for the next meeting to better show the need for additional lights in the park.

Sign Permits were discussed and approved Trustee Hoppe motioned for the approval and Trustee Barrera Seconded the approval for Discount Smoke and Liquor at 300 E US 69 HWY sign permits.

Chief Coonce spoke on the need for an ordinance covering Terroristic Threats. The board agreed that there is a need for that update. Chief Coonce stated he would work on getting an ordinance for an upcoming board meeting.
