A goal for next year will be to have a key code, so if someone is injured or there is a fire, those affected would have immediate access to everything they may need. Trustee Jett asked if they still need an air conditioner. They do, but they are getting by. Right now, the funds being donated will go towards next year's insurance to make sure they can keep

the building. Trustee Jett also asked about the heater. He offered to check it out for her. Chairman Bradich thanked Kim for all of her hard work with creating the non-profit and everything that she has done for the Village. She also shared that they are looking for volunteers for this winter, to work twice a month at the Pantry.
