

MINUTES OF BOARD OF TRUSTEES REGULAR MEETING SEPTEMBER 22, 2025 28 S DRAKE AVE CLAYCOMO, MISSOURI 64119

Meeting Start: Chairman Bradich called the Regular Meeting of September 22, 2025, to order at 7:01 PM.

Trustee Benton led the Pledge of Allegiance. Police Chief Coonce led a moment of silence for Charlie Kirk.

Trustee Jett motioned to approve the Payment of Bills for September 5, 2025, through September 19, 2025, seconded by Trustee Keelin. Roll call: Trustee Barrera: Yea, Trustee Jett: Yea, Trustee Benton: Yea, Trustee Keelin: Yea, Chairman Bradich: Yea. Motion carried.

Chairman Bradich brought for discussion: New Business License Application for Drive Plus/Drive Plus Auto Sale at 247 NE US-69 HWY. A representative from the business was present. It will be a used car dealership in the same location as L&S Auto. Fire Chief Shaumeyer had concerns about Fire Code. The current plan is not up to code. Trustee Jett suggested holding off on voting, to conduct more research into safety for emergency vehicles. Trustee Keelin brought up discrepancy in the application vs. what they are presenting to the board. (44 cars on application/20 cars in presentation.) He said 44 is the maximum capacity of vehicles, overall. They would only have 20 cars on the lot at a time. Trustee Benton shared concern for safety codes as well. Trustee Barrera suggested that the application be clarified. It was agreed to revisit this at the next Board meeting on October 13.

OLD BUSINESS

- Police Chief Coonce: Update on Terroristic Threats made at the Ford Plant. Another one occurred on Sep. 16 (bomb threat and active shooter), still searching for suspect. On Sep. 18, an employee was fired and threatened to come back and shoot everyone. Charges are being filed. Since this is becoming a more common occurrence, he will be meeting with Ford security representatives tomorrow to create a plan to deal with these threats. He added that there is an officer attending the board meeting, and in future meetings, an officer will be in attendance as well. It will be the regular on-duty officer (so no overtime or extra money from the budget.) If the officer on duty gets a call, he will leave for the call. Chief Coonce is always armed and on duty, when attending. He reminds everyone about National Night Out against Crime, this Friday, Sept. 26 from 5-7pm at Mildred Keeney Memorial Park. Several new vendors this year.
- Fire Chief Shaumeyer: Sold the old ambulance for \$5,100. Received the check from Purple Wave. The new fire truck will be available to check out at Night Out Against Crime on Friday. Last full-time position has been filled.
- Village Clerk Wymore: Thanked Trustee Barrera for making enchiladas for Office staff last week. Also thanked board members that helped with Clean Up Day.

- Public Works Director Kane: No old business.

- Trustee Jett: Asked for an update on the suspect from Rocket Stop. Chief Coonce shared that he has not been apprehended yet, but they know who he is and are doing their best to locate him.

Chairman Bradich shared that they have been ticketed. Chief Coonce added that they will continue to write them tickets and escalate if they do not comply. Trustee Barrera asked if the residence behind McDonald's (30 N Bryant) is still receiving tickets. Yes, and will continue. He thanked everyone who volunteered for Stream Team. They had a good turnout.
