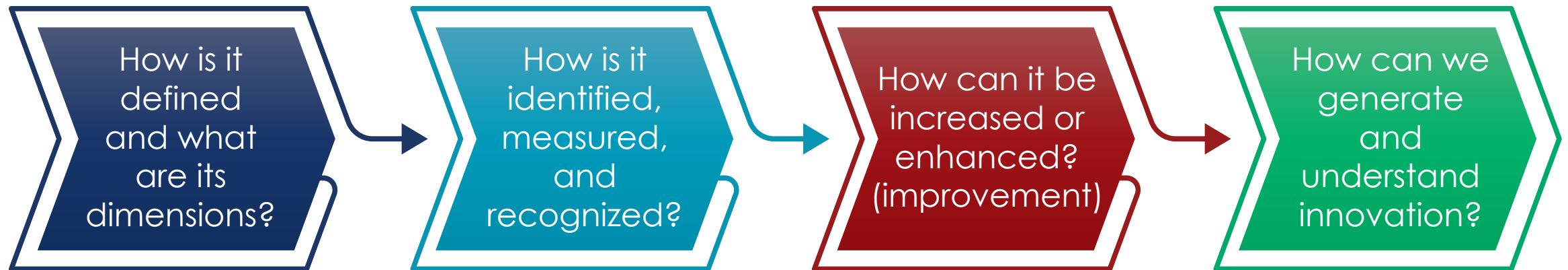
What's the Value in Accreditation?

- **Strengthen** programs through structured review process
- **Share** successful practices in collaboration with partners
- **Gain** professional development and growth through participation
- **Build** stronger stakeholder relationships through data sharing
- **Improve** program effectiveness by engaging stakeholder
- **Make** credible quality claims via third-party validation

Accreditation as a Professional Conversation

Accreditation: a **profession's** conversation with internal and external stakeholders on critical questions about **quality**



Operational Principles

Collaboration

Collaboration rather than competition among providers moves educator preparation forward.

Innovation

Innovation is integral to the continuous improvement cycle.

Partnership

Partnerships among providers, state authorities, and AAQEP support mutually beneficial work.

Comprehensiveness

A **comprehensive** system serves **all providers** with the same quality expectations.

Operational Principles (cont.)

Context

Context and institutional **mission** are recognized and respected.

Consistency

Consistency and calibration of reviews and decisions are critical to their credibility.

Efficiency

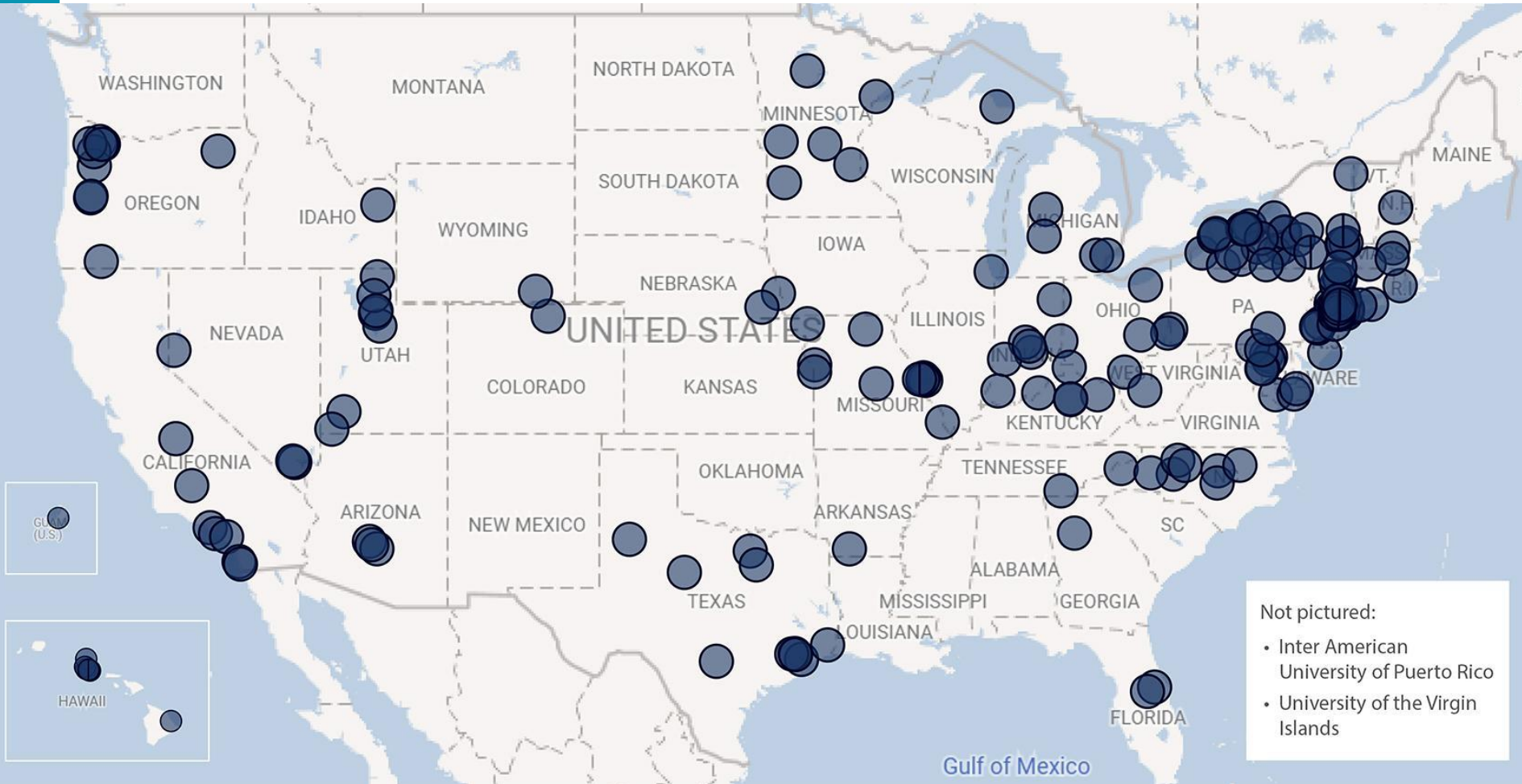
Operations maximize **efficiency** and strive for **frugality** while maintaining quality.

Sharing

Broad dissemination of findings and innovations benefit the field as whole.

Conceptualizing the Dimensions of Quality

(APPROVED 2025 Standards)

Foundational expectations	STANDARD 1: Completer Foundational Knowledge and Skills Program completers have the foundational knowledge and skills to effectively support student learning and development.	STANDARD 3: Quality Program Practices The provider's resources and internal quality control practices ensure its capacity to effectively prepare educators to support success for all learners.
	Shared questions or challenges that demand local solutions and invite innovation; reflection of specific institutional missions; responsiveness to state requirements	
Contextual expectations	STANDARD 2: Completer Professional Growth and Adaptability Program completers grow as professionals and adapt their practices to support student learning and development as appropriate to their role and context.	STANDARD 4: Program Engagement in System Improvement The provider engages with partners and community members to strengthen the P-20 education system and to promote success for all learners.

Standard 1 Aspect Topics* – Completer Foundational Knowledge and Skills

- 1a. Foundational knowledge and skills for effective practice in their professional role
- 1b. Learning science/learning theory, including social/emotional learning
- 1c. Knowledge of the diverse and intersecting aspects of human identity
- 1d. Language development, language acquisition, and literacy development
- 1e. Knowledge of student exceptionalities/federal and state requirements
- 1f. Current ed technology tools and systems
- 1g. Cognitive, social, and emotional growth and development

Standard 2 Aspect Topics* – Completer Professional Growth and Adaptability

- 2a.** Relationships with families, guardians, caregivers
- 2b.** Culturally responsive practice with diverse learners in diverse settings
- 2c.** Productive learning environments in diverse contexts
- 2d.** International and global perspectives in practice
- 2e.** Assessment by gathering evidence to inform student learning
- 2f.** Professional conduct, goal-setting, and growth
- 2g.** Supports for mental well-being, including the impact of trauma

Standard 3 Aspect Topics* – Quality Program Practices

- 3a.** Recruitment, admissions, and formative support processes for candidate success
- 3b.** Coherent curricula aligned to relevant standards
- 3c.** Effectiveness of evidence-based practices
- 3d.** Quality clinical experiences in documented, effective partnerships
- 3e.** Effective assessment system (data quality)
- 3f.** Effective internal quality control system
- 3g.** Capacity for quality and institutional commitment to the program

Standard 4 Aspect Topics* – Program Engagement in System Improvement

- 4a.** Engages with partners to support high-need schools and reduce disparities in educational outcomes
- 4b.** Engages with partners to investigate and plan improvement
- 4c.** Supports completers' career entry
- 4d.** Works with partners to meet state and local workforce needs
- 4e.** Works with partners to diversify educator workforce
- 4f.** Uses publicly available data to inform program improvement
- 4g.** Meets state or jurisdiction mandates

Familiar Accreditation Fundamentals

PROCESS

Self-study is the heart of quality assurance and improvement

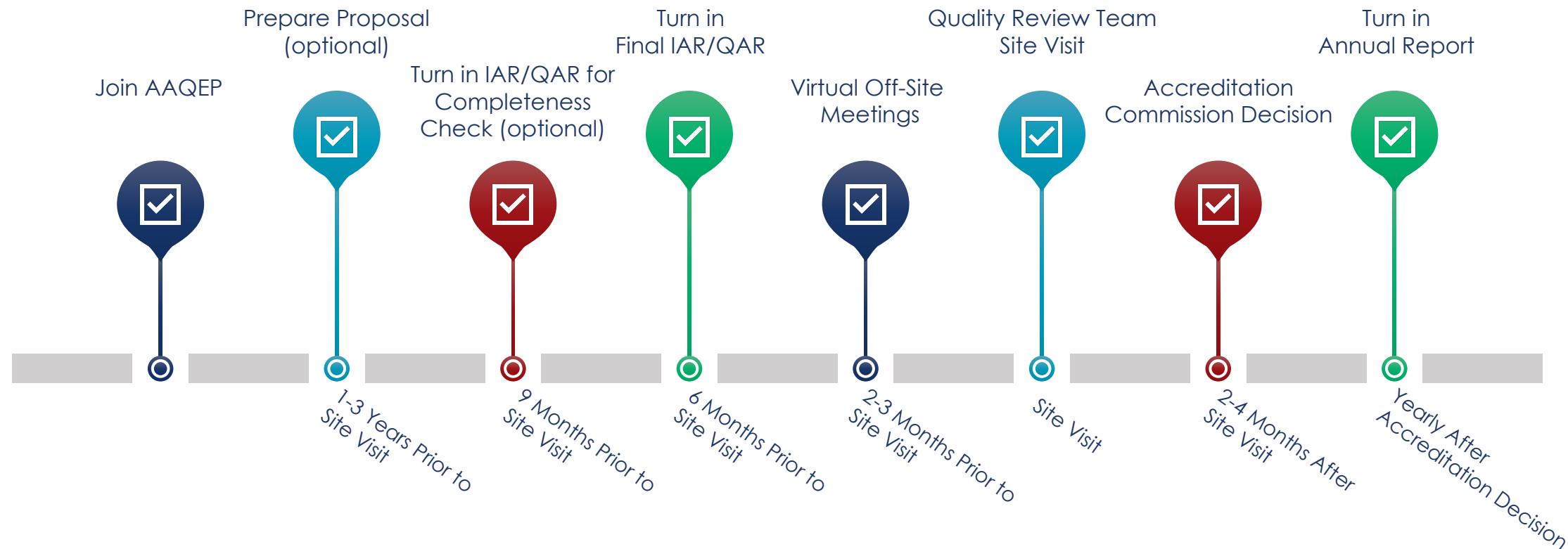
Peer-review provided in off- and on-site reviews

DECISIONS

Accreditation decisions rely on professional judgement

Accreditation term of 7 years or initial accreditation term of 5 years; may include identification of quality issues and shorter terms

Timeline for Quality Assurance Reviews



Pathways in AAQEP Accreditation

5-year (Initial) Accreditation

Maximum of 5 years

One time only

AAQEP Visits: 5-year (Initial) and 7 year

- Include a provider-selected **Local Practitioner** who brings understanding and knowledge of local context
- **Small team** with a small footprint when on site
- Teams give **no judgment or recommendations**; they only collect and affirm evidence
- Lead to timely (and transparent!) **virtual decision meeting** (@3 months after visit)

Engaging Stakeholders

Involve faculty, candidates, and community partners

- Multiple measures have reasonable continuity with multiple perspectives
 - Program faculty, P-12 partners, program completers, and graduates' employers

Evidence requirements & priorities

- **Quality of evidence** must be investigated and shared
- Priority is given to **direct performance measures**
- **Indirect and downstream measures** must be considered
- **Differentiation of evidence** occurs by license, level, location, and mode
- Assessments are **appropriate to the program and context**
- There is clear indication of performance expectations for assessment measures (**criteria of success**)

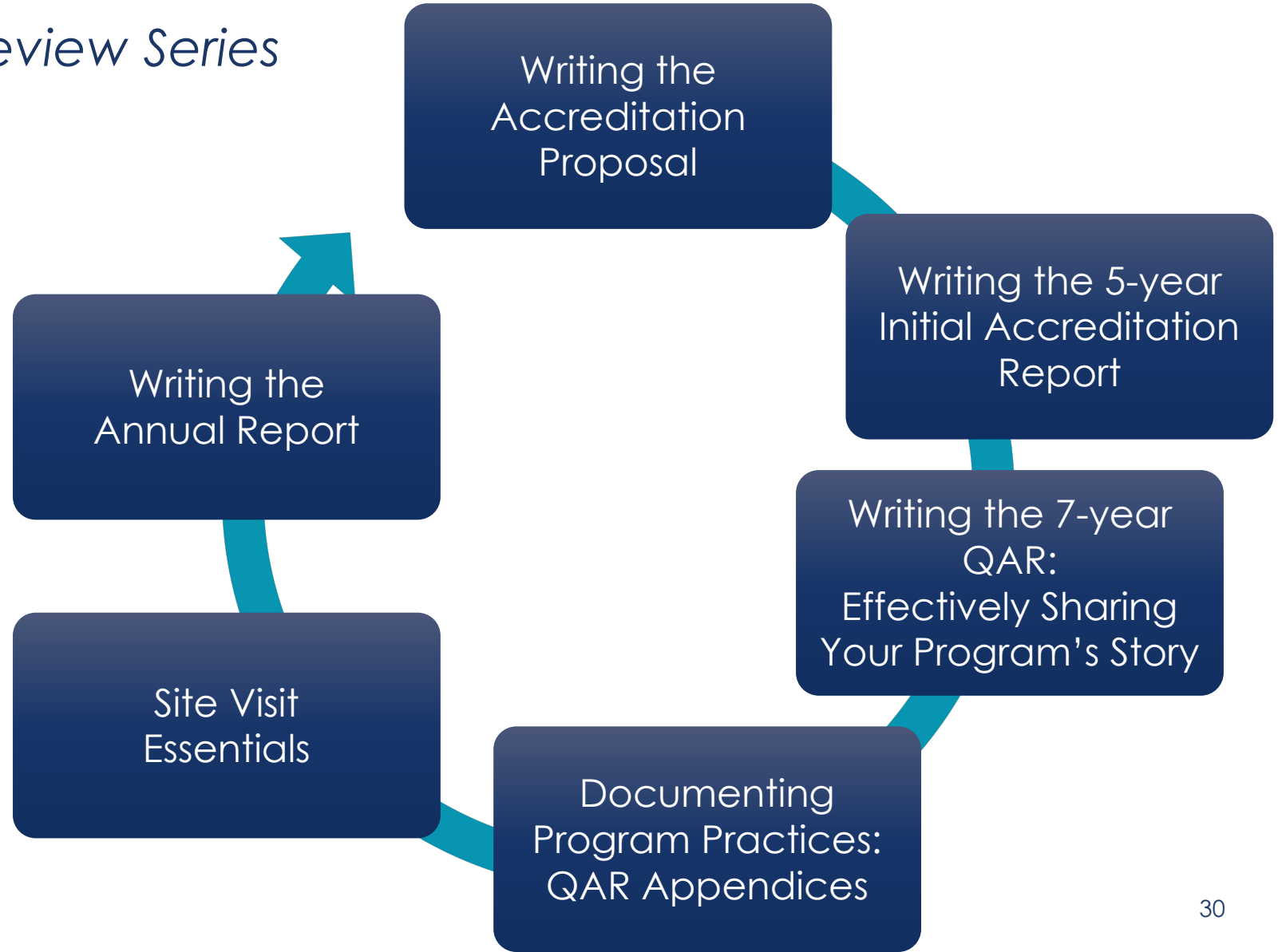

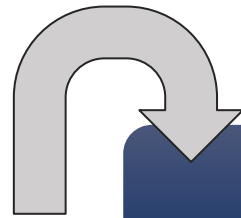

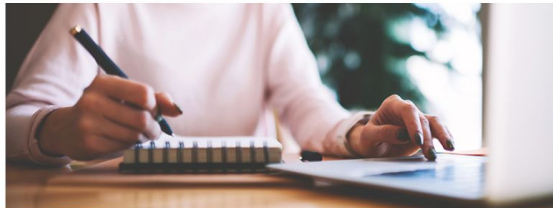
