As Managing Director at Calcon, he oversaw the provision of a wide range of marine surveying services including several international oil majors, ship owners and both P&I and marine insurers. These services included break bulk cargo surveys (steel pre-loading, paper), cargo lashing and P&I condition surveys, bunker surveys (representing DNV Petroleum Services in Southern Africa), liquid cargoes including crude oil and chemicals. He also established and oversaw Calcon's liquid chemical export program which included the transportation of hazardous liquid cargoes by road.
