
# Animal Protection Issues in Nepal

- Companion Animals Free-roaming Dogs,
   Cows, Population Management, Rabies,
   Extreme Animal Cruelty
- Wildlife- Biodiversity, Loss of Habitat, Human-Wildlife Conflict
- Farmed and Working Animal Welfare, Animal Transport and Related Issues
- Environmental Degradation Deforestation, Uncontrolled Natural Resource Usage, Air and Water Pollution, Waste Management
- Climate-Related Impacts, Melting Glaciers,
   Water Resources, and Natural Disasters, Glacial
   Lake Outburst Floods (GLOFs).
- Animal protection laws are virtually non-existent, no Animal Welfare Act, and weak enforcement of existing laws.
- Corruption pervades all aspects of society and impacts animal welfare





# Pre-GAP Activities (SAVE Nepal Initiative) and Early GAP (January 2024 – November 2024)





# Student Mentorship and Interactions

- Varnika set up a WhatsApp group with the four students so that we could easily communicate throughout the semester.
- Julie and Varnika worked with students in Professor Shiva Paudel's Legal Research Methods course to help them with their proposals and papers. They also reviewed and provided feedback to students about their work.
- Meetings with students in a social setting to discuss animal law and opportunities for future research and learning.
- Each student received a \$ 250 stipend for their participation in this experiment as an incentive to become involved (~ 34,000 Nepal Rs) and a gift packet with a certificate of completion.






















# Spring Activities (April 10-May 15) 2025 Julie's Visit to Nepal

- Several new students have expressed interest in getting involved in research and learning about animal law after attending the talks given by their peers.

















## Plans for the Second Half of the Year

- Julie and Varnika will each develop a six-week course to introduce the field of animal to law students in Nepal. The courses will be made available on a password-protected website to be completed asynchronously. We will involve students in helping us pilot-test the courses.
- Julie will create a general overview course, and Varnika will develop an in-depth course that explores existing animal laws in Nepal and compares them with what exists in India.
- We are tentatively planning to offer several other research opportunities for students during the remainder of the year.
- We are also working with several new students who have expressed interest in becoming involved and learning more about the field of animal law. We are sharing information about opportunities that exist around the world to pursue an LLM in animal law.



## Future Plans - Post-GAP Year (after Oct. 31, 2025)


- We plan to continue interacting with all of the students who have expressed interest in animal law.
- We plan to involve the students in helping us "pilot-test" the courses that we will be developing during the second half of the year.
- We are encouraging graduating students to consider applying to an animal law LLM program, once they have completed their JD degrees.
- Julie is planning, through the SAVE-Nepal initiative, to host the first-ever animal law conference in Nepal and is working with Matthieu Ricard to get his book "A Plea for the Animals" translated into Nepali.























#### Highlights to date
