Tuition is based on total annual cost of the program and divided into 10 equal payments. Terms & Conditions :

1) A \$150 Non-Refundable Enrollment Fee (\$100 for re-enrolling families) is due upon signing to guarantee your child a spot at our school. Your canceled check is your receipt. Paid \_\_\_\_\_

2) Tuition Payment Plans (Please Check One)

\_\_\_\_\_ Full Payment – Payment of \$ \_\_\_\_\_ to be paid in full by 7/1/2018 (reflects 5% discount).

\_\_\_\_\_ Semi-Annual – Two equal payments of \$ \_\_\_\_\_ with 1st payment of 50% due 7/1/2018 and the 2<sup>nd</sup> payment due 12/1/2018 (reflects 2% discount of annual tuition).

\_\_\_\_\_ Ten Installments – Ten (10) equal payments of \$ \_\_\_\_\_ due the first (1<sup>st</sup>) of each month, 8/1/18 through 5/1/19

**NOTE:** A \$35 late fee may be assessed if the tuition payment is not received by the fifth (5<sup>th</sup>) day of each month. Failure to pay the tuition within thirty (30) days of the payment due date will result in interest accruing at an annual rate of 18% on the sums past due and may result in Student dismissal. Should it be necessary for the School to engage an attorney to defend or otherwise enforce its rights under its relationship with the undersigned, the undersigned agrees to pay School legal fees and costs.

2) All students must be potty trained prior to August 27, 2018.

4) The undersigned understands that all students are accepted on a six week trial basis. In the event that the enrollment is terminated by the school, the Enrollment Fee will be refunded but tuition for time in school will be charged.

5) The undersigned understands and agrees that to assure the stability of the school that they will give a 90 day notice if the student will be withdrawn and is responsible for tuition during that time period.

- Exceptions:
- a) Student moves 20 or more miles from school
  - b) A replacement student is enrolled
  - c) The school dismisses the student for cause
