He said the lake levels are low, over a1/2 foot lower than last year at this time. The treatment plant has been working on inventory and finding all the valves for the city for their chip seal project.

8.1 Clear-Well & Pump House, 8X30 Filter, Lake Line Extension and Lake

Pump House Project. General Manager Costner said T&S has dug all the dirt out for the foundation and is putting down road base. They are ready to pour the foundation and block walls. General Manager Costner said the new generator is up and running. All major tie ins are completed.
