If inclement weather forces closure, there will be no refund. There will be no refunds in the event of an emergency closure. There will be no refunds of booth fees after May 1, 2022. Vendors must follow directions given by the AIP Committee and their designated volunteers. Pets must be controlled at all times when present at the event. NOTE: 501(C)3 Non-profits will not be required to pay the GCA fees but will need to complete application prior to event.
